

watch 24/7 as they provoked us in attempt for creating violence; encroached marking out landing areas with luminous tape for guiding helicopters in night landings and directing ground troops to our dwellings and locations.

While media portrayed us as violent people "holed-up" on a 900 acre foreclosed ranch; we were actually 20+ ordinary people on over 7,000 acres, 4 ranchsteads; well supplied; poorly armed... three children; 4 elderly people and NO warrants for any of us.

We had some contact with people outside... daily, we routinely conducted a wide circle reconnaissance to be sure we were not being encroached on; day and night — Every 3rd or 4th day we rode 2 or 3 horseback on a much wider perimeter recon — Those revealed their efforts to mark ground in rough terrain for landing helicopters and marking trails that the marking tape could be seen day or night.

Early on we would tear off the tape — then, shortly we learned to remove it where it was tied to weeds and tree limbs and re-route it into wrong directions and mark landing tape in rough hill sides where landings would result in crashes.

We were constantly surveilled by Cessna aircraft day and night for about 6 weeks — then, it seemed it became too expensive or fruitless; or both and we seldom saw this — on one occasion, near Ralph Clark's house they buzzed several of us men, it appeared in an attempt to draw fire — We were not tempted. Our purpose; to keep the peace; never to force violence.

Our wives kept chili on a constant fire — we used deer and beef stock for ground meat — all lived primarily on that source, as needed. We baked bread and supplemented from ~~our~~ canned vegetables and fruit, as well. By May 1 we planted about 1 1/2 - 2 acres of garden.

Media kept speaking of running out — not in the last 100 years. Janet Reno said on national TV ~~as~~ they were cutting off the water, as some of us watched not 25 yards from a 25 acre lake and 150 yards from a fresh water spring, one of many. They did shut off the electricity, but neither that nor fuel was a pressing need. The feds provided all for us.

We were in Garfield county: Indian Country. The feds have NO authority over non-Indians in Indian Country. They simply declared war on We-the-People and attacked us with the purpose of silencing us and destroying us by force. In 10:10

We were Kidnapped; robbed of our motorhome; our Suburban; our computerized office and supplies; much of our personal property; our friends suffered similar losses — The freeman was robbed of a \$17,500 Canon copier less than 6 months old — and none of us had violated a single law.

DeRoy, over a 5 year period, settled over \$9 billion in obligations for The people — still settled to this day.

We did not surrender peacefully voluntarily. We were threatened within 24 hours of morning of 12 June 1996, with full scale assault; and, the murders of us and our families, if we did not surrender to the lawless; violent tyranny at our gate by 4pm on 13 June 1996. We were Kidnapped!
