Guantanamo North. Like so many things, media

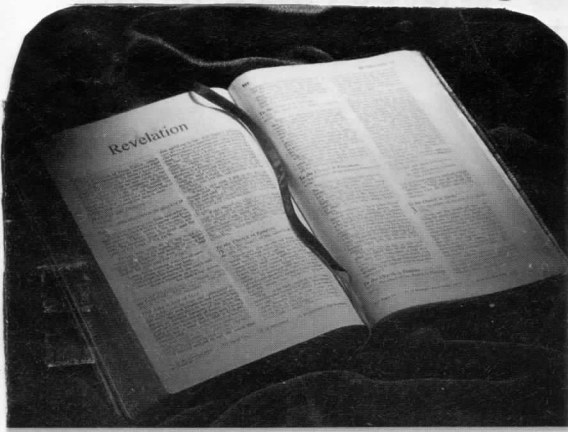

America. Millions jailed, arrested, imprisoned for no actual
crimes at all. "Prison Bonds for Credit" (trillions) - Adolf Hitler never had
it so. It's the biggest business today on the "land of the free;
and the home of the brave." (It is none of that any more.)

The many nations at large on America are under the
judgment of the Almighty - Hollywood anti-Christ a-
moral dictating abominable morals - They've cast the
Word (written) in the ditch and wasted away in all.

When I was first here at CMU, Terre-Haute they put CTU and that address on papers; since, there seems a will for more secrecy, so it does not come up. There are a limited number of actual political prisoners, like myself, who never leave. Only one is here, who was here when I arrived last week of July 2008. I have seen a complete turnover 2 1/2 times since I got here. Those of us who know we are falsely imprisoned, and even those who have a clue; who know what must be done to secure lawful, legal liberty, are secreted away — held unlawfully. Here near Terre Haute, Indiana, we are in a building outside the perimeter fence of the Federal Correctional Institution (FCI). A building that as a "death row" was

3/ ^x CONDEMNED! Once condemned this late 1930s building was never renovated. It is in deplorable condition. The water and sewer are totally unsafe. Only 30% of the showers work at all. What they call SHU (Special Housing Unit) is a "hole" where one suffers filth; horrid heat; and poor circulation of air — it is unlawful, a torture chamber! This was never, nor could it ever have lawfully been, authorized by Congress or otherwise. The alleged "policy" is a "FRAUD" — no basis. It is in violation of Universal Postal Union Treaty (Law); in violation of the Constitution for the United States of America 1787-1791; totally unlawful. Families and friends, as well as those of us here, are suffering as the violation of our rights fall on them as to phone; e-mail; the mail; visits, etc. Only those who have experienced it have a clue. This is all a crime and 80-100 people are the victims; their families victims, as well.

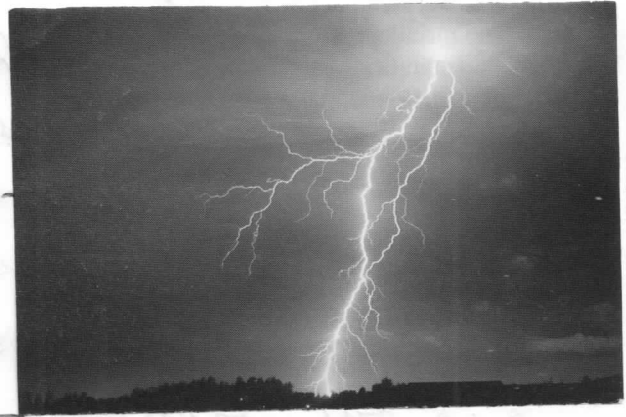
I have 13 grandchildren. Only 3 have ever seen me

"NOTHING" is as it appears to be! NOT one thing!!! People generally have what I call the "Perry Mason Syndrome". They do not ever imagine any arrests, jail, nor imprisonment could ever happen to them. They "imagine" that if, God forbid, they were ever wrongfully arrested and accused, they would get a good lawyer like Perry Mason. All would be straightened out quickly and their lives would go on as they please. BUNK! I would never work that way. NOT when there is a BIG multi-million dollar PAY-OFF for the tyrants if you go to prison, and there is! It need not have anything to do with what you did or did not do. And there is NO Perry Mason in the wings to rescue you. (I'll pop your bubble. The real Perry Mason never won a case!)

CMU - ? It is not about monitoring one's communication with family, community, outside world. It is all about silencing one, even or especially "The whole TRUTH". And not only here, but "NEVER" has my wife, Dana, ever been allowed to visit me in the whole last 17 of the now 21st year we've been brutally separated. Mail sent to her last known address is never delivered. This despite no matter what she may be doing, the address would never go away.

I am thankful these last several months, as we have a couple people with a great deal of control who are much more compassionate and helpful than those the first seven years here. Some of those who were here got out, as they could see they were being called upon to do that which is clearly unlawful to us and our families. ~~_____~~ I have been told 3 times early on that I would "NEVER" leave CMU. Why?

Let me share some "foundation". If you owe — the answer would be to settle, right? (Matt. 5:25). It is either that or argue a negative (no win argument). By May 25, 2007, while "designated" at USP McCrory at Pine Knot, Kentucky, McCrory County I settled both previous accounts (Montana & North Carolina). Those who had framed me in the first place did not favor my release, so, by 17 June 2007, they cooked up another set of "bogus" charges in Oklahoma City. No problem, Matthew 5:25, I proceeded for immediate settlement (agree w/ thine adversary). They were not satisfied. They took me to Oklahoma City and tried to get me to "argue" — NOPE! From last of July 2007, through April 2008, that whole SItAm was played out. My settlement stood. I accepted the Bonds; in exchange for my "exemption" — settled! They sequestered me in a hospital room at Grady County so I could have "NO" contact with anyone — not even Kool-ride from an orderly. After several weeks they put me on a


7/ plane to send me back to Piche Knot. When I got to USP
McCreey Receipt and Delivery (RAD) the people knew me and
promptly were sending me onto the compound for a room with my
property. I was walking down the hall and a man called
out, "Lauder, come back here. You can't go out there. We
don't know what you are doing here. You're NOT 'designated'
here nor anywhere else." He then said, "You're going
to the hole!" I retorted, "Don't I have to be 'designated'
to go to the hole?" To which he declared, "You're going to
the hole!" They held me in the "hole", no contact from
the last week of May 2008, thru part of the last week
of July 2008. Then they put me and my property on a BOP
van and hauled me to FCI near Terre Haute, no word
as to where I was going, no notice, and after some
juggling they took me to a back door (wrong door) where
I was taken in to what I learned was CMU/Guantanamo
no North - The terrorism unit. I've been here ever since.
They refused to let me write Dana for over 3 yrs - no
reason given. No outdoors where one can put his feet
on the grass. Crowded - abuses - including weeks in
"The Hot-Box" / "HOLE" - months of no phone - no con-
tact with any of my family - nor anyone else.
Property stolen - mail stolen, verified with addresses,
and others sent to me, never received - such as CRIME.
In summer 100° - no air cond. - in winter - some
rooms heat well, others do not... I could go on and on!
I have two teeth that are breaking up... No help available.

I am including a "Briefing" re: Inside "Guantanamo North" - and my Affidavit re: factors here. It is hard for one here to secure "verification" so, of necessity, I am limited to firsthand experience, memory and only that actually in view. Thank you for bearing with me.

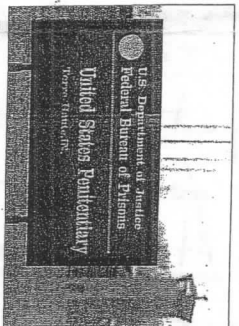

Boston bomber *Dzhokhar Tsarnaev* has been sent to a maximum-security federal prison in Terre Haute, Ind. *What's it like?*



top to let in some natural light. If the inmates become frustrated and act out, their limbs are strapped to their bed for days at a time, in a process known as foot-pounding. Even former ADX warden Robert Hood has gone on record describing the prison as a "clean version of hell." This place "is not designed for humanity," said Hood.

Has anyone objected?
Yes. Eleven ADX prisoners have filed a class-action lawsuit against the Federal Bureau of Prisons (BOP) arguing that prolonged solitary confinement violates the Constitution's Eighth Amendment prohibition of cruel and unusual punishment. One inmate, Jack Towers, said he was driven so mad by the lack of human interaction that he bit off his own finger and amputated his own testicle. "There are instances of people who literally go insane in solitary confinement," said psychology professor Craig Haney. "I've seen it happen."

Is this happening just at ADX?
Not at all. Solitary was once reserved as a way of punishing and controlling the most disruptive or dangerous prisoners in maximum-security lockups. Yet in prisons throughout the country, 80,000 inmates are now held in ADX-style isolation on any given day. Prisoners can be isolated for months on end for the slightest of infractions—such as posting something on social media, or talking back to a guard. ACLU campaigner Amy Fedak says an increasing number of prison officials in both red and blue states are beginning to "recognize that solitary confinement has been overused and abused in the last 30 years."

Does solitary confinement work?
Studies show that it does not reduce prison violence, and as a form of rehabilitation, it's a disaster. A 2001 study of Connecticut prisons found that solitary inmates were 50 percent more likely to be re-arrested within three years of release than nonisolated inmates. "It was meant to make inmates improve," said Maine prison warden Rodney Bowdard, of solitary. "The reality is that exactly the opposite happens."

That's because long stretches of solitary fill prisoners with rage and make it difficult for them to function in the real world, which they find overwhelming (see box). Now just 21, Tsarnaev—who has no hope of ever being released—will likely never leave solitary, unless it's to be executed. "He's looking at spending potentially at least the next 30 years in isolation," said associate law professor Laura Rovner. "It's almost unathomable."

Are all terrorists sent there?
No. Had Tsarnaev avoided the death penalty, he could have served a life sentence at the only federal supermax in the country: ADX Florence, in Colorado. Nicknamed the "Alcatraz of the Rockies," ADX houses some of America's most notorious criminals, including the "space bomber" Ted Kaczynski, and inmates spend 23 hours a day in a concrete cell averaging 12 feet by 7 feet, with a 4-inch window at the

Who ends up in this prison?
Home to federal death row, the maximum-security penitentiary in Terre Haute, Ind., boasts a menacing mix of terrorists, serial killers, white supremacists, and child molesters. Emergency combatant John Walker Lindh, the so-called American Taliban, will be one of Tsarnaev's new neighbors; so, too, will Abduwali Mass, one of the Somali pirates who took on Capt. Richard Phillips. The facility is also home to the execution chamber where Oklahoma City bomber Timothy McVeigh met his end in 2001. Tsarnaev, 21, is currently appealing his sentence to avoid that fate, but while he does so, federal death row's newest and youngest member will probably spend at least a decade in a facility so restrictive, it's earned the nickname "Guantánamo North." Sister Rita Clare Gerard, an activist who has worked with death-row inmates, said prisoners are kept isolated in tiny cells all day, with almost no human contact. "Truthfully, I don't know how they keep their sanity."

What's inside Terre Haute?
There are two special units. Tsarnaev is likely to be placed in the Special Confinement Unit (SCU), built in 1993 to house federal death row inmates. Details on the prison are scarce, but inmates are believed to spend almost every waking minute in their cells, furnished with a bed, shower, desk, toilet, sink, and 13-inch television. Sister Rita reported that inmates went outside for just five hours a week—and even then, usually only to wander into designated cages to exercise and take a peak at the sky. One inmate found those conditions so hellish, said the ACLU, that he volunteered for execution. Tsarnaev also might end up in the Communications Management Unit (CMU), a special 50-cell facility for terrorists and other dangerous prisoners. The inmates there are remotely watched and monitored every minute of every day by a team of intelligence officials in West Virginia. That unit, and other isolation units, were designed to keep terrorists from radicalizing other inmates or slipping dangerous messages to fellow terrorists outside.

Life after solitary confinement
Transitioning back into society after imprisonment isn't easy—and it's even less so after solitary confinement, which research has shown to cause severe psychological damage. Robert King spent a staggering 23 years in solitary in the Louisiana state penitentiary before being released in 2001 for a 1972 murder he didn't commit. For those three decades, King spent every day peeing up and down his 8-by-6-foot cell, counting to himself as he did so. Whenever he was caught trying to communicate with other inmates, King would be played for a month in the "cold box" of Camp 1, going for bloods of 10 days without any interaction, even with a small slot in the cell door. "I was depressed every day," he says. The sensory deprivation of solitary has permanently damaged King's sight, and he finds it difficult to judge distances after living in such a small space. More than a decade after his release, says King, he still gets "confused as to where I am, where I should be."
