## IN SUPPORT OF SCHAEFFER COX

When reviewing the circumstances of Cox's corrupt conviction one must start with the governmental department involved with the corruption and their history, as well as those who perpetrated the false circumstances surrounding Cox's conviction.

The department involved is the DEPARTMENT OF JUSTICE.

My memory of history dealing with the DEPARTMENT OF JUSTICE goes back to the murder of an individual named Vicki Weaver. She was shot and killed while holding her baby. This was called the "Ruby Ridge" incident. (This governmental behavior along with the "Waco" incident would lead me and others, in Michigan, to exercise our Constitutional Right of forming a Militia in 1994. It would become known as the Michigan Militia.)

Vicki Weaver's assassin was Lon Horiuchi, an FBI sharpshooter. The DEPARTMENT OF JUSTICE refused to prosecute him. And refused to allow the State of Idaho to prosecute him. A civil suit was filed and the federal government settled with Vicki Weaver's family for \$3.1 million. Thereby, making the people

pay for the bad behavior of a government cop all the while protecting him from Justice for Vicki Weaver.

Unlike the unsuccessful Nuremberg defense of; "I was only following orders." It worked for the defense of Lon Horiuchi within the DEPARTMENT OF JUSTICE's behavior.

As documented in this history channel statement.

"In 1997, FBI agent Lon Horiuchi was charged by an Idaho county prosecutor with involuntary manslaughter in the death of Vicki Weaver, but a federal judge dismissed the charge in 1998, citing the alleged immunity of federal officers from state prosecution."

So it was no surprise to me when the DEPARTMENT OF JUSTICE refused to allow Alaska to prosecute Bill Allen (key witness in the corrupt conviction of Alaska's Senator Ted Stevens.)

For it was alleged that Bill Allen was involved with under age prostitution and was apparently promised immunity if he helped convict Senator Ted Stevens.

Ted Stevens was one of my Senators from Alaska. He was corruptly convicted by the DEPARTMENT OF JUSTICE. Senator Ted Stevens lead attorney was Rob Carey. A private man, well respected in his chosen profession.

In 2014 he wrote the book "Not Guilty: The Unlawful Prosecution of U.S Senator Ted Stevens.

He did not want to write it. But after Senator Stevens tragic death, in a plane crash, his wife Catherine Stevens convinced Carey to write the book.

In the Author's opening note, Carey states-

"Our criminal justice system is broken, it needs reform. United States v. Stevens is a textbook example of what can go wrong in a criminal case. IF THE GOVERNMENT CAN CONCEAL CRITICAL EVIDENCE FROM A U.S. SENATOR, IT CAN CONCEAL EVIDENCE FROM ANY CITIZEN. I believe

that what happened to Senator Stevens has happened more frequently than most of us could imagine. "

Near the end of his book he again refers to the DEPARTMENT OF JUSTICE corrupt behavior.

"The Ted Stevens case and hundreds of others listed on the website of the Innocence Project prove that we cannot count on prosecutors to give defendants a fair trial. As Judge Sullivan said, [in regards to the Ted Stevens case] Thank goodness we don't have to count on the United States to give him a fair trial"

Fortunately Senator Stevens could afford a strong legal team consisting of 12 Lawyers. Highly paid and still ended up with his conviction. But thrown out when a whistleblower came forward, after Stevens lost his reelection bid in 2008.

How many high paid lawyers did Schaeffer Cox have? And he fights, for the truth in the court system, alone in his appeal process.
