

In support of Schaeffer Cox #8 May 16, 2017

I appreciate your patience as I have spent a great deal of time exposing our governmental corruption in the DEPARTMENT OF JUSTICE. One last word in that regards. (Maybe not the last word.)

In Chapter 24 of Rob Cary's book "Not Guilty: The Unlawful Prosecution of US Senator Ted Stevens" Cary states: ". . . the Department of Justice published a series of memos addressing concerns about the Department's discovery practices and emphasizing that federal prosecutors would receive increased training."

Really? Are we to believe the corrupt conviction of Ted Stevens was because of ineptness from all those involved, . HOGWASH. The DEPARTMENT OF JUSTICE is corrupt. Most, if not all of their senior attorneys work to convict, regardless of truth or Justice.

Cary goes on by saying; "Ninety six percent of federal criminal cases are resolved by plea bargains, so the rule [Brady Rule] puts defendants at a disadvantage in negotiation: without access to information in the government's files. . ."

This becomes important in those cases where the accused demand a trial. It is why the senior attorneys in the DEPARTMENT OF JUSTICE , lie and cheat to get a conviction. For they bully the accused to accept a plea deal. Not with Senator Ted Stevens or my friend Schaeffer Cox.

I will now develop the background which generated the corrupt/evil conviction of my friend Schaeffer Cox.

Not all justice department attorneys are corrupt or evil. Many start their careers with optimistic belief they can protect our nation from evil doers. Once they see the evil doers in the DEPARTMENT OF JUSTICE they quit. Or at least the honest ones do.

Joseph W. Bottini is an evil doer in the DEPARTMENT OF JUSTICE. Please review the attached Schuelke Report. According to Mr. Schuelke; the lead witness in the Stevens case (Bill Allen) had sex with a 15 year old prostitute named Bambi Tyree. As I stated in previous posts; The DEPARTMENT OF JUSTICE did not allow the state of Alaska to prosecute Bill Allen for his illegal behavior. But I digress.

No other Attorney in the DEPARTMENT OF JUSTICE is mentioned more than Bottini, in the Stevens case. (As presented by Mr. Schuelke) He was also the lead attorney in the Cox case. That is, until his corrupt behavior was exposed in the Stevens trial. We must expose the corrupt attorneys in the DEPARTMENT OF JUSTICE.

On April 7, 2009 Federal Judge Sullivan ( Presiding Judge on the Stevens case) ordered an investigation into the corrupt conviction of Senator Ted Stevens.

Attorney Henry F. Schuelke III was asked to do the investigation. It became know as the Schuelke Report. Attached is the 525 page report. To date I have only read the Summary.

In it Mr. Schuelke expressed how the DEPARTMENT OF JUSTICE withheld “significant exculpatory evidence which would have independently corroborated Senator Stevens defense and testimony, and seriously damaged the testimony and credibility of the government's key witness.” (Bill Allen)

It sounds exactly as Joseph W. Bottini did to my friend Schaeffer Cox.

Mr. Schuelke goes on to say “As a direct consequences of the dismissal of the inditement against Senator Stevens, the conviction of Peter Kott and Victor Kohring, Alaska state legislators were reversed, and new trials ordered because significant exculpatory evidence in those cases was concealed from the defense. . .”

And who was the key attorney in those cases. None other than Joseph W. Bottini.

Somehow we the people are to believe that Schaeffer Cox received a fair trial given Joseph W. Bottini was involved in developing the case against my friend Schaeffer Cox. HOGWASH.
