

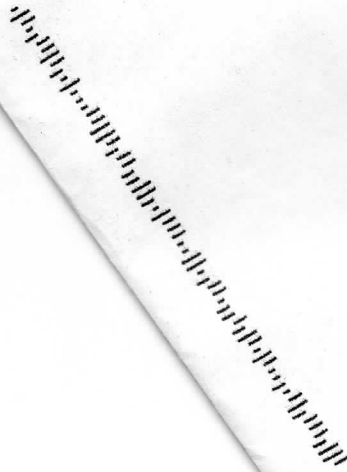

Dear Mr. President: Re: "Hue and Cry"
