Hi,

I want to point out something that I have picked up on as a highly consistent pattern with this government. I don't know a name for it so I will give it one, "Inversionary Projections of Guilt." It is a process whereby the government accuses some innocent person of the doing or plotting to do horrible things that the government itself is actually guilty of doing.

It is "inversionary" because the government accuser turns reality upside-down and claims the exact opposite of the truth. It is a "projection" because they pin blame on some innocent scapegoat. And feelings of the government's own "guilt" is what drives them to obsessively engage in this ritualistic pageantry.

It is not unlike the Roman crucifixions or the celebration of another's condemnation that soothed the weak, self-loathing mobs that filled the coliseum. Those who cheer for death and torture do it because they know in their hearts that they are in fact the ones who deserved to be torn to pieces.

There is invariably a tremendous amount of pent up anxious rage that churns inside one who is made in the image of a just God, but nonetheless lives by the Lucifarian Ethic of "might makes right" and "do what ever you think you can get away with." This person knows in their subconscious spirit that they are at odds with the Supreme Judge of the Universe and that their dreadful day of reckoning is coming sooner or later. This literally drives them mad. They feel a momentary respite from the inner torment as they watch an innocent one cry out in pain under an undeserved punishment.

The spirit of these devilish people knows that they needed to be redeemed by the sacrifice of One who was holy and blameless. They know that that sacrifice has been made once and for all. They also know that it was not made for them, but for The Elect. These lost and angry souls have no hope of redemption. They never did. They never can. It was written long ago. Going through the motions of crucifying innocence and projecting their guilt onto another will not cure the fact that they are excluded from God's love and His redemptive plan. But it's all they have, so they hunt down God's people, tear them to pieces for a public spectacle, feed them to the lions of time, and hurl accusations that grow from the guilt that blackens the accuser's own heart. It is all to no avail. But mimicking what they can not have --one to take the consequences of their sins-- is all they have left do.

This takes place on both the micro and the macro scale. If you look for it, you will see it and it will help you understand the true nature of the conflict we are in. My case is only a small glimpse of the bigger ceremony of injustice that is this present age, but it is nonetheless quite illustrative of my point. Take these few examples:

- 1. The drug trafficking cops in Alaska plotted to murder me to "fix the Schaeffer Cox problem", the Ft. Wainwright MPs got wind of it and came and warned me.
- -1. The US Attorney charges me with plotting to murder federal officials even though the evidence shows the opposite to be true
- 2. The Feds pay no attention to the Law, do whatever they want, never get prosecuted, and then rub it in everyone's face. From spying on us, to illegal wars, to importing drugs and pimping toddlers, to shooting people on the street for sport, it's all illegal and it just keeps on going.
- -2. The Feds accuse me at trial of wanting to set myself above the law
- 3. The Feds light buildings on fire in Waco, then shoot little children as they try to run out.
- -3. The Feds get liars-for-hire to take the stand and say that I was plotting to set homes on fire and shoot little kids as they run out.
- 4. The Feds in Anchorage run a child prostitution ring out of the Ocean View House. They destroy countless lives in the

process. OCS (Office of Child Services) supplies the "pets" for the sex parties.

- -4. The Feds file a bogus complaint saying that Marti and I and our big, loving, God-fearing family are neglecting our 1 1/2 year old son Seth, so we have to give him to the pervs that run OCS.
- 5. The Feds are building bunkers, buying bulk ammo, planning for a HUGE civil war, building militarized police forces, and publishing manuals that say that veterans, gun owners, Tea Party, Conservatives, Christians, and Pro-Lifers are the enemy.
- -5. The Feds claim at trial that because I own a safe full of guns and believe in the original and plain meaning of the 2nd Amendment that that proves I am obviously plotting to murder the government.
- 6. The Feds lie to the jury about everything. They say I was NOT leaving, that I did NOT reject Fulton's pushes for violence, that I did NOT say we need to pull a Gandhi, that Fulton did NOT attack Les with a knife, that RJ Olson was NOT a thief and a liar and on and on for six weeks.
- -6. The Feds suppress their own recordings that show the truth and then Prosecutor Skrocki gets up there in his closing arguments and lists off all the truths I said (that he knows are true) and tells the jury that I'm lying. Then the Judge backed up Skrocki and said I was lying, this after he had just read the truth in black and white in the sentencing memo that was filed UNDER SEAL so the public could not see it.
- 7. The feds destroyed 4 families, bankrupted 16 people, blew \$18 million in taxpayer money, deceived all of Alaska, and sent innocent people to prison for basically life, all so that the Feds could keep on committing crimes undetected.
- -7. The Feds claim to the jury and to the press that I only think of my self and do not care about the people or the good of my community
- 8. The Feds run a psyc-warfare unit in every state that rigs elections, sends out plants like Aaron Bennett and Bill Fulton, uses the NSA to get dirt on public officials and blackmail them, floods the air waves with propaganda disguised as "cop drama" TV shows, teaches kids in schools to be submissive mind-less slaves, poisons the food and water so people will be dumb and compliant, blocks international news, tells us we are worthless helpless weaklings who need the government to survive, and then sends us the bill for all of it and puts us in prison if we can't pay.

- -10. The FBI goes around to every one I know and sits them down and plays, "you may think you know Schaeffer Cox, but you don't. Let us tell you about the real Schaeffer Cox. The bad Schaeffer Cox."
- 11. All these power crazed Feds are on a collective self-worshiping delusional bender. It's obvious they are completely detached from reality. Just look at our House and Senate and the whole DC quagmire.
- -11. The judge has some quack shrink pronounce that I'm nuts and suffer from "a collective political delusion" because I think the government is a corrupt joke.
- 12. There has never been a government in the history of man that has gotten this far gone and been able to reverse their fall and avoid collapse. This government has no redeeming social value.
- -12. The sentencing recommendation for me said that I needed a 35 year sentence because I was not able to change and had no redeeming social value.
- 13. Drug trafficking State Trooper, Ron Wall, posted snipers outside my house during the "investigation". They watched me and my family through rifle scopes from the wood line 100 yards away as we went about our normal life at home.
