• TRUMP PARDON STRATEGY •

Alright, here's how I think we should approach the Trump Administration for relief. The overall argument will be: "US v. COX is a test case that is trying to set brand new precedent for '2nd Amendment thoughtcrime.' It was Obama and his crowd trying to end-run congress to go after gunowners. Trump needs to stop the DOJ from pushing this bad case through the 9th Circuit NOW, before it's decided against gun v. rights & freedom."

We could ask for a pardon or a commutation of sentence, but that wouldn't save everyone else from the bad case law my case is about to set. Does Trump want to put this anti-2nd Amendment case in the hands of the same 9th Circuit that just sided with the Muslim invasion over the president's travel restrictions? I doubt it.

He could tell the US Attorney to not oppose my appeal. He could tell them to move to dismiss the

charges, or he could order the US Attorney to hand over all case files to the defense; which would cause the US Attorney to drop the case rather than comply with the order.

The hard part is making this happen fast, before the court can set that bad precedent. But if we are organized, we can do it. Here's an outline:

1. I'll fill out the petition for Commutation and put my 'own' letter with it. The theme of my letter will be:

"I'm not a criminal. I'm loyal to Trump. This is much bigger than just me. If you let me out I'm not going to go commit a crime and make you look bad. You know I'm safe because I already proved it when, even with Fulton threatening my life, I still said no to violence. That's why they tried me on 2nd Amendment thought crime, not in actual crime."

2. We need Larry Pratt, President of Gun Owners of America, to write a letter to attach, the theme of which is:

"This case outlaws the BELIEF in the 2nd Amendment. Schaeffer Cox didn't do anything. The prosecution is claiming that Schaeffer Cox believes that the Second

Amendment was put there by our founding fathers so that normal folks could stand down the government, by force, if it ever turned on the people; and that this belief should now be treated as criminally conspiring against the government. They couldn't confiscate the guns, so they're trying to set up a way to confiscate the gun owners. It's 2nd Amendment Thought Crime! Please don't let your DOJ put this case in front of the 9th Circuit. Please drop the appeal or dismiss the charges. It's a fringe anti-gun theory of law that the Trump Administration should not advance. And Schaeffer's a nice guy who America needs out of prison, incidentally."

3. We need a letter from my US Senator Lissa Murkowski to attach that says basically:

"The prosecutors responsible for this case are cheats and liars. I don't doubt they are doing Schaeffer Cox dirty. They almost certainly hid evidence from the defense, lied to the judge, and broke all sorts of rules. That's their M.O. on political cases. So if you want to let Schaeffer out, that's probably good."

4. We need a letter from retired head of the State Trooper's Post in Fairbanks, Mr. Hal Hume, that says:

"I was a trooper all my life. I know Schaeffer and his family well. Schaeffer supports honest law enforcement. And honest law enforcement supports Schaeffer. I know this case and I was close to Schaeffer leading up to his arrest. He's not violent, or a criminal, or dangerous. He's a Good Fearful man who cares about his family and his country. Any claims that he would plot some kind of crime are all lies and fake news. He's an innocent man. This is just anti-2nd Amendment politics. It's only right to let him out."

(5a) We need a letter from Scooter Welch that says:

"I'm the former Fairbanks Police Department's Chief of Police. My daughter is married to Schaeffer's little brother. We all live in Fairbanks. Schaeffer isn't a criminal, but what's been done to him might be criminal. It was very corrupt at the least. Schaeffer needs to be out with his children. He needs to meet his niece and nephew - my grandchildren. I know who's dangerous in this town, and it's not Schaeffer Co. Please let him out."

(6) We need some well known pastors, preferably ones personally known to Trump, to write letters that say:

"This is not only 2nd Amendment thought crime legislation through litigation, it's also religious persecution. The prosecutor said right to the jury that they needed to convict Schaeffer Cox because 'he believes in God's Law'. I've listened to the tapes myself. It's un-American and scary. This case is pushing an anti-gun, anti-Christian, anti-American agenda and the Trump Whitehouse needs to pull the plug on it and let Schaeffer Cox out of prison."

(70) We need to get our direct mail place to send out millions of postcards to all my donors so they can write a note on them and send them to the Whitehouse. (Richard & Maria are currently blocking this.) Over several months, we could literally get Trump sent hundreds of thousands of postcards. They would read like this:

"Dear President Trump, Schaeffer Cox is an innocent political prisoner of the Obama Administration. Please drop this case before the courts have a chance to create case law that allows honest patriotic Americans like me - and YOU - to be thrown in prison for our theoretical willingness to stand up to tyranny 20 or 30 years from now. What happened to Schaeffer Cox is wrong. I support you, President Trump, and I know you can't support what's being done to Schaeffer Cox and his family. You should let Schaeffer out of prison because: (space to write-in additional comments.)"

8. We also need to attach the "Press Release" to this petition. But before we do that, we need someone - probably Rudy since he knows the case so well - to go through the Press Release and insert pictures, exhibits, and hyper-links to corroborating news articles and to Rudy's best YouTube's. That way the Press Release is tied in with real life context, and isn't just a fairytale in a vacuum.

9. We need Robert John to give us a letter to go with it that says:

"I'm a superman hot-shot appellate attorney. I worked extensively on Schaeffer's legal team. This Orwellian... case seeks to expand the already overly-broad conspiracy statutes to include non-specific theoretical willingness to resist a government if it starts committing crimes against the people. In 30 years of practice, it's the most scary thing I've seen. If you want to 'Make America Great Again,' tell your US Attorney to quit pushing this bad case. Or if you want a less direct approach; order the prosecution to hand over all the case files to the defense. Once they stop withholding those, we can negotiate this case away before it goes to the 9th Circuit and sets horrifyingly bad precedent for 2nd Amendment thought crime. And by the way, Schaeffer was a talented political leader, well liked by everyone who knew him, and very sociable.

He poked-fun at the system, made people think, and got people to have fun while doing it. That's why he was dangerous. He wasn't, and isn't, a violent criminal."

10. In addition to the letters we attach to the petition, and the postcards to the Whitehouse, we need to put an outline letter on our www.framed.schaeffer.com website so people who didn't get a postcard can send a letter to Trump. The outline will be:

11. We should also use FB, Twitter, YouTube, etc. to get a "stop the thought crime test case" whitehouse.gov petition going. We can also push this in our direct mail efforts, (If Richard and Maria step aside)

12. Last but not least, it would be good to hire an attorney spokesperson to shepherd this through. As my attorney, they can call to check up on things and get other attorneys to actually talk to them. They can also make deals to make my case go away, talk to my prosecutors, and call me in prison. (Again Richard and Maria will have to give me the Jonded funds they are holding hostage, if we want this to happen)

These 12 steps are the basic plan I think we should work off of going forward. Hopefully some people can split up the work, track down the people, get the letters, and get this moving.

Most of these letter outlines I gave are summaries of letters those people have already given for sentencing, or of things they have said. But any good letters from well respected influential people would be good to attach.

Three Steps:

1. Petition with high profile letters attached
2. Ongoing barrage of individual cards/ letters
3. Negotiate an end to the case that avoids setting precedent for "2nd Amendment thought crime."

We're got nothing to lose, everything to gain, and this will be fun.
