As a result of their stand-off, the IRS simply refused to prove the existence of any such law requiring them to pay the federal income tax and deferred to a kept federal court to issue a default ruling on behalf of the U.S. government.

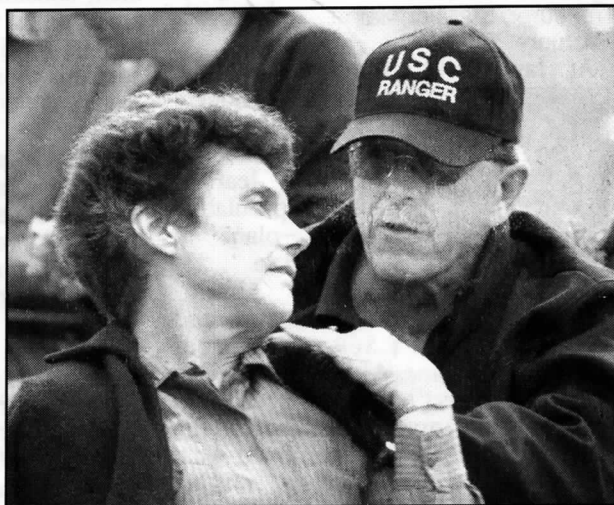
Since they have been held in federal prison, and their beautiful home in Plainfield, New Hampshire was seized, it is now beginning to deteriorate due to lack of upkeep.

"After four years we still haven't been able to get on the properties and conduct a proper video inventory of what damages were done by the government and what they have stolen without lawful-due process," Ed Brown told the *Fort Fairfield Journal*. "In

the meantime the property is deteriorating and the damages are compounding. As well, we are still waiting for a court of competent jurisdiction that we can seek damages for our unlawful, fabricated incarceration and torture. The best word we can use for what the governments at the local, county, state and national have done to us is "genocide".

laws using the tried and proven tactics of threat, duress and coercion rather than admit they are functioning within the States with no legal authority.

The Browns offered to pay the fed-

eral income tax if the IRS could prove its jurisdiction, but it continues to avoid the issue. "We always offered to settle this matter from day one," explained Brown, "but the government has always refused, to this day, to provide evidence of a bona fide law requiring us to pay."

The Federal government only has

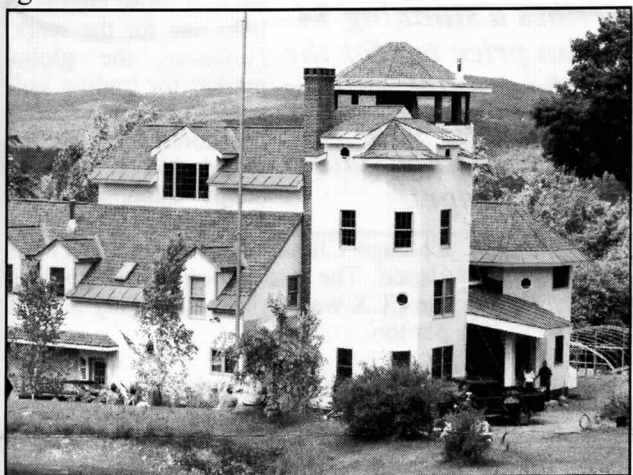
authority to exercise its jurisdiction on military posts and bases, naval dockyards, lands sold or ceded to the federal government by the State legislatures (such as national parks and federal buildings) and territories and possessions of the United States. There is no grant of authority to the U.S. federal government to exercise or enforce its legislation—especially a direct income tax—within the several States in the Union. All federal power within that context is exercised arbitrarily and illegally. The Browns

simply stood up against the illegal actions of the federal government and found themselves in prison for—based upon their current ages—what may be the rest of their lives.

Tax Protestors' Abandoned Home Now Deteriorating

MSHA's \$4 Billion Pipe Dream

At last week's board meeting, the new commissioners of the Maine State Housing Authority (MSHA) learned about a speculative 20-year plan to weatherize all 476,729 single-family homes and 8,369 apartment buildings in Maine. Although started in 2009, the project has barely been mentioned during my 14 months on the board. Last week, we questioned what appears to be well over one million taxpayer dollars spent on carbon consultants, computer systems, and staffing connected to the plan.

The 9-page plan document describes a stunning \$4 billion price tag for the weatherization venture -- 30% more than the entire annual state budget. The project is to be funded from three sources: \$3.2 billion of revenue bonds sold to investors, and a combination of \$757 million of taxpayer subsidies and futuristic carbon credit sales.

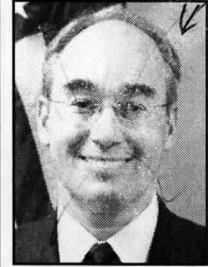
Although we asked for the plan details at the board meeting, few were forthcoming to the commissioners. We were told to expect a staff presentation at the March meeting.

Here's how I believe the Authority expects to fund the 20-years' of weatherization...

MSHA sells \$3.2 billion of "revenue bonds" to investors.

The proceeds are used for \$5-10,000 weatherization loans to homeowners that pay for the work. Homeowners repay the loans to MSHA, which then uses the cash to pay the interest and principal to the bondholders.

But, what happens if a homeowner doesn't repay his/her weatherization loan? Does MSHA rip out the installed insulation and try to resell it? This payment stream seems quite unlike a family paying off a home mortgage or car loan, where the dwelling or vehicle serves as ample collateral for the bank



ment subsidies and Jetson-like carbon credit sales for this funding. In 2009, MSHA received \$42 million of federal stimulus money to weatherize approximately 5,000 Maine homes. The \$42 million has been spent; the one-time stimulus money is gone. With the federal government \$16 trillion in debt, and our state government struggling to balance its budgets, where are the additional weatherization subsidies going to come from?

Lastly,

MSHA has made a big bet on voluntary carbon credit trading to augment the taxpayer subsidies.

Since 2010, the Authority has asked several thousand Maine homeowners to sign-over their "carbon credits" after each received approximately \$6,500 of weatherization work. MSHA somehow quantifies the amount of reduced carbon emissions from burning less heating oil (or other fossil fuels) because of the additional insulation. Board members were told that MSHA has collected 7,000 tons of carbon credits. The weatherization plan relies on a projected \$16 per ton value for each of those credits to help pay for the work. However, the global market for trading voluntary carbon credits has collapsed with the worldwide refusal to adopt expensive cap and trade laws. The

Chicago Climate Exchange (CCX) has closed. The last carbon credits sold on the CCX were priced at roughly 5 cents per ton.

The time and resources to develop a \$4 billion plan to weatherize Maine residential buildings has come with a cost to vulnerable Maine families and taxpayers alike.

At last week's meeting, the MSHA board was told that \$850,000 of taxpayer dollars has been spent so far on carbon consultants, computer systems, and related expenses. Another \$250,000 will likely to be spent to fully develop the program, we were told. The new board members have asked for the financial records to see if even more has been spent.

All the while 800 fellow Mainers

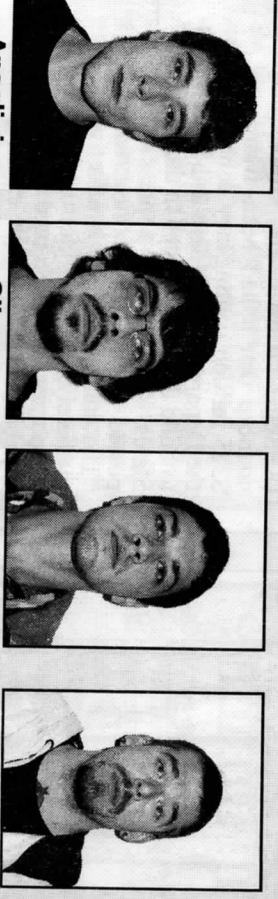

MDEA Agents and Presque Isle Police Disrupt Heroin Trafficking Ring

MDEA Agents and Presque Isle Police have charged four suspects following a criminal investigation into reports of heroin trafficking in the "Star City," John Ansolini, 21, of Fort Fairfield and Troy Marchant, 25, of Presque Isle are charged with two counts of Class B - Unlawful Trafficking in Heroin. 24-year-old Joshua Willette is charged with Class A - Aggravated Trafficking in Heroin. Brian Gilmer, 23, of Presque Isle, is charged with Class B. Theft of a Firearm and Violation of Conditions of Release.

The investigation began over the weekend following reports that heroin was being sold from a home on Dragon Drive in Presque Isle. Agents were able to purchase heroin on two occasions from Marchant and Ansolini, which agents allege came from Lorraine Michaud's home on Dragon Drive.

On Tuesday night, MDEA Agents and Presque Isle Police executed a search warrant at Michaud's home, seizing heroin packaging, scales, a

firearm to the drug evidence, Joshua's offense is aggravated.

Agents and Presque Isle Police determined that the firearm seized from Willette belongs to Brian Gilmer's father. Agents determined that Gilmer took it without his father's permission, so he is charged with theft. Gilmer was already on bail for theft. All of the suspects were taken to the Aroostook County Jail.

Heroin seizures and arrests have been on the rise across Maine for several months, working their way from south to north.

Since the early 1960s, the U.S. Central Intelligence Agency (CIA) has been directly involved with assisting third-world drug farmers and dealers in the cultivation, production and transportation of morphine base and refined heroin into the U.S. to provide an off-the-books revenue stream for their "covert ops," and to provide money to buy off local tribal chiefs in southeast Asia. More recently, the U.S. Marines have officially begun assisting poppy farmers

TAMC to Convert to Heating with Compressed Natural Gas

Project Estimates Show Cost Savings of Up to a Half Million Annually

PRESQUE ISLE, Maine - The Aroostook Medical Center (TAMC) in Presque Isle became the first in the state, and what is believed by officials to be the first in the nation, to break ground on a project that will allow for a conversion to heat with compressed natural gas (CNG). CNG is a form of natural gas that is stored under high pressure. It is one of the cleanest and safest fuels available.

At a groundbreaking ceremony for the innovative energy project, TAMC leaders said that once the conversion is complete early next spring, the healthcare organization will save an estimated \$400,000 to \$500,000 in annual heating costs at its largest facility - A.R. Gould Memorial Hospital on Academy Street in Presque Isle.

Fort Fairfield Rotary Hosts District Governor

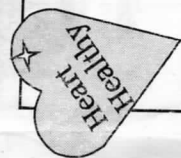

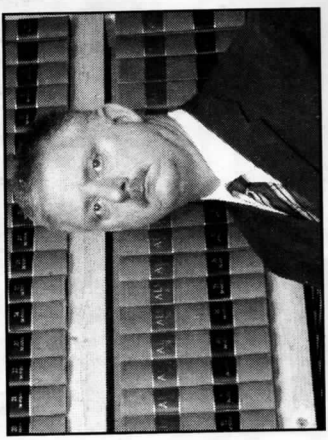

Concentration Camps for U.S. Citizens During Civil Unrest

With over 175 million people in the United States accustomed to receiving some form of welfare benefit, disability income, food stamp program, free cell phone or free health care, the national and state governments, which are in debt to the tune of trillions of dollars, are rapidly reaching the point where those benefit packages are no longer sustainable and soon large segments of society will be forced off the dole and to fend for themselves. When that happens, an entire class of people not accustomed to taking care of themselves or their family without the monthly assistance of a government check or electronic bank transfer will become very unruly and various think-tanks have predicted violent riots will break out across the country. But, don't fear, the U.S. government

has been developing a concentration camp style system with the U.S. Army and will clamp down on society, placing everyone who defies the iron fist of the president into a prison camp where they will be made to labor for their daily bread, until such point that the government determines those prisoners are no longer needed and exterminates them.

Sound radical? Yes, it is, and in one form or another it is what has happened in every country throughout history that has tried socialism's welfare benefits scheme and found themselves unable to sustain a population base that decides not to work and instead sits around waiting for government to steal from one class of citizen in order to give to another. NAZI Germany (NAZI stood for the National Socialist German Worker party) of the 1930s through 1940s is an extreme example, but Communist China, the former Soviet Union, North Korea, Uganda and Zimbabwe also stand as examples of ruthless police state aggression against their citizenry when the government is no longer able to take care of its people, has run out of money, and needs to conduct population and resource control in order to maintain its power monopoly and control of its angry, disenfranchised citizens.

After adopting all the planks of Karl Marx's Communist Manifesto over the past 100 years, the United States is now no different than any other socialist or communist country and the U.S. Army has been developing procedures to quell dissent and keep

the establishment in power at all costs when either the money runs out, or the welfare checks won't be enough to pay for the massive increase in the cost of food and living.

Now, don't get me wrong, I'm not bashing welfare recipients, here. As Star Parker so eloquently states in her book, *Uncle Sam's Plantation*, "Welfare is a sociological monster, perhaps birthed with the best of intentions, but now unwieldy and insidious, damaging the very people it was intended to help. If we are ever to slay the beast, we must understand its origins and where it went so terribly wrong." Welfare, as Parker points out, is a slave system designed to control a class of people and as I point out here, historically ends in prison camps, destitution and death of society.

Internment and Resettlement Operations

In February, 2010, the Headquarters, Department of the Army updated its Field Manual FM 3-39.40, *Internment and Resettlement Operations Manual*. It describes the Army's procedures for dealing with various classes of prisoners. The ones we're interested in here are: the Dislocated Civilian (DC), which are civilians who have been moved from their homes due to either natural or man-made disaster; and the Civilian Internee (CI), which is a civilian who is interned during armed conflict, occupation, or other military operation for security reasons, for protection, or because he or she committed an of-

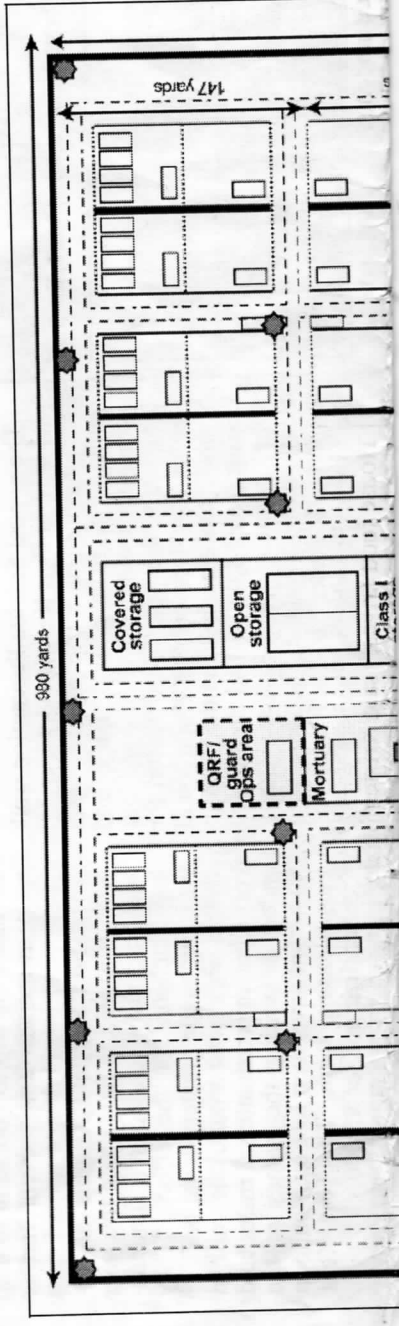
fense against the detaining power. Other classifications are Retained Persons, Enemy Prisoner of War and Military Prisoner. For the purposes of societal breakdown and domestic riot control, though, we will just be dealing with the Civilian end here.

Martial Law

While the Posse Comitatus Act prohibits the use of the military for domestic, civilian law enforcement purposes, it can be suspended whenever Congress feels it's necessary and allow the Army, Marines, or any other branch of the military to either assist or completely take over local law enforcement duties. "The Posse Comitatus Act prohibits the U.S. military from enforcing civilian laws within the United States or its territories without specific authorization. The U.S. Constitution and other federal, state and local laws may directly and significantly affect operations in the U.S. and its territories if the enforcement functions in such cases require an authorization through a congressional act (for example, Title 10 USC, Sections 331 through 334 [Insurrection Statutes] or a constitutional authorization (for example the President invoking his executive authority under Article 2 of the Constitution). U.S. Army National Guard soldiers operating in a nonfederal status are not restricted by the Posse Comitatus Act (see Title 32, USC, and JP3-28)."

Camp Construction and Protocol

U.S. concentration camps have been designed to hold as few as 300 people, or as many as 4,000 or 8,000. On January 24, 2006, Halliburton Company's subsidiary, KBR (Kellogg, Brown and Root) announced that it had been awarded a \$385 million contingency contract by the Department of Homeland Security to build detention camps in the United States. According to a press release posted on the Halliburton website, "The contract, which is effective immediately, provides for establishing temporary detention and processing capabilities to augment existing Immigration and Customs Enforcement

event of an emergency influx of immigrants into the U.S., or to support the rapid development of new programs. The contingency support contract provides for planning and, if required, initiation of specific engineering, construction and logistics support tasks to establish, operate and maintain one or more expansion facilities."

A few years later, in November, 2011, KBR issued a Request for Proposal to subcontractors to provide products and services at their newly constructed concentration camps. Services up for bid included catering, temporary fencing and barricades, laundry and medical services, power generation, refuse collection, and other services required for temporary "emergency environment" camps located in five regions of the United States. KBR's call for FEMA camp service bids arrived soon after the Senate overwhelmingly passed the National Defense Authorization Act (NDAA) which permits the military to detain and interrogate supposed domestic terror suspects in violation of the Fourth Amendment and Posse Comitatus. Section 1031 of the NDAA bill declares the whole of the United States as a "battlefield" and allows American citizens to be arrested on U.S. soil and incarcerated in military prisons.

In the event of civil unrest, the U.S. military will be called in to conduct law enforcement activities and begin rounding up dissidents. The first place those dissidents will end up is a Detainee Collection Point, which is usually a school, church, warehouse or sports stadium, whichever is available. The Detainee Collection point may be operated by civilians such as local law enforcement until such time that the prisoners are transferred to a Detainee Holding Area or Theater Internment Facility under control of the Army.²

Resettlement operations will generally be conducted by Military Police, who provide population control such as enforcing curfews, restricting

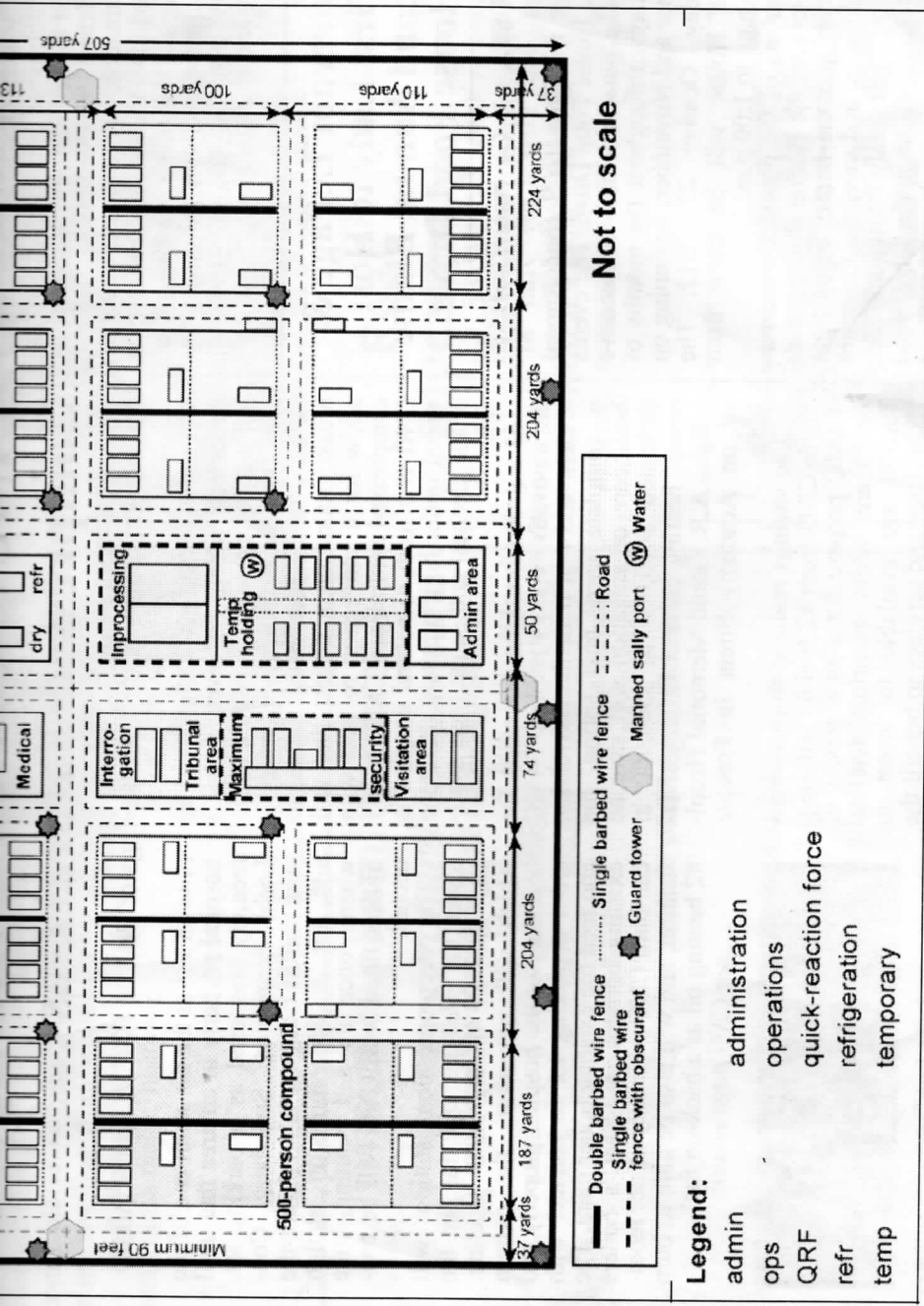


Figure J-1. 4,000-capacity I/R facility for compliant detainees

Figure J-1 shows a typical U.S. Army concentration camp, also known formally as a Theatre Internment Facility (TIF). This TIF is comprised of four 1,000 person enclosures, each with two 500-person compounds. Facilities can also be expanded to house up to 8,000 detainees. movement, checking travel permits and registration cards, operating checkpoints, instituting amnesty programs and conducting inspections. ³ They will also conduct resource control with licensing, regulations or guidelines, checkpoints, ration controls, amnesty programs and facility inspections. ⁴

Life in the Camps

"Many military police express support for physically exhausting activity in detention as a positive outlet for energy that may otherwise be used for energy productive purposes." ⁵ You can read "counterproductive" as doing anything the government doesn't want you to do. While in the camps, "sports clubs may be organized within the facility for this purpose. Time and space are set aside to accommodate detainees' physical exercise." ⁵

The detention center commander may also approve religious discussion groups under the direction of a government-friendly patsy who will steer and direct the group, using religious faith, to follow the dictates of the government. "Clerical leaders who are chosen to participate must be carefully vetted and are typically selected from moderate elements of their respective religions." ⁶

Agricultural work farms are also planned for Civilian Detainees. "Where practical, detainees will be required to raise vegetables for their use. This work is classified as paid work. Agricultural and gardening projects are particularly desirable because they provide gainful employment for large numbers of individuals. The food produced by the gardening projects provides a valuable supplement to detainee diets at a minimal expense. The produce from gardens is U.S. property. It will be used for the benefit of detainees and U.S. armed forces and will not be sold or traded in civilian markets." ⁷

Psychological Operations (PSYOPS) are key to a smooth running concentration camp and PSYOPS officers are trained to "effectively support Internment/Resettlement operations..." such as, "...developing a PSYOP program and conducting PSYOP to pacify, obtain cooperation from and coordinate

We're Already in the Camps
In many ways, we are already living
under a martial law concentration camp
system with our vehicle registration and
driver's licensing; hunting and fishing
licenses, police checkpoints, Crimestop-
pers amnesty program, food stamps and
welfare benefits rationing; and OSHA,
DEP, CPS and TSA inspections. Those
of us who do labor are forced to give a
large portion of our income to the gov-
ernment controllers in the form of taxa-
tion and are left with a pittance of
money for our efforts.

Public schools, colleges, universities
and the mainstream media are the
PSYOPS officers who condition and
mold the mindset of the public to accept
government authority at all costs, no
matter how dictatorial or oppressive it
may be.

While we on the outside of conven-
tional prisons don't have forced labor
work farms yet, people do labor and the
U.S. government considers that labor its
property and taxes it obsessively
whether the money is earned inside the
U.S. or in another country.

The only difference between the
Army's concentration camp and the
concentration camp-at-large system just
described is we have not yet been put
behind barbed wire with armed guard
towers around us. But, the end result is
the same; we're imprisoned, are regu-
lated, licensed, rationed, taxed and con-
trolled just the same. It's when the pub-
lic becomes unruly that things will
change for the worse and the govern-
ment, seeking to maintain its monopoly
of force and power, will slam us all into
its prisons and turn our country into
another tin-horn socialist/communist
dictatorship to be logged into the history
books as yet another failed state.

§ 106. Constitution Day and Citizenship Day

- (a) **Designation.** September 17 is designated as Constitution Day and Citizenship Day.
- (b) **Purpose.** Constitution Day and Citizenship Day commemorate the formation and signing on September 17, 1787, of the Constitution and recognize all who, by coming of age or by naturalization, have become citizens.
- (c) **Proclamation.** The President may issue each year a proclamation calling on United States Government officials to display the flag of the United States on all Government buildings on Constitution Day and Citizenship Day and inviting the people of the United States to observe Constitution Day and Citizenship Day, in schools and churches, or other suitable places, with appropriate ceremonies.
- (d) **State and local observances.** The civil and educational authorities of States, counties, cities, and towns are urged to make plans for the proper observance of Constitution Day and Citizenship Day and for the complete instruction of citizens in their responsibilities and opportunities as citizens of the United States and of the State and locality in which they reside.

1. Internal Affairs Documents (Request 1)

In his motion to compel production of documents, Plaintiff requests the Court to compel production of any and all documents that concern or are relevant to the incident described in the Complaint, including those documents that concern the entry and search of Plaintiff's residence; police internal affairs investigations relating to the incident; statements or interviews of witnesses, informants, Plaintiff, and any police officers who had any role or contact with the case; incident reports; and tapes and transcripts of radio messages made concerning the incident and all reports of such radio messages.

Defendants have agreed to produce the documents concerning the entry and search of Plaintiff's residence, all incident reports, and all tapes and transcripts of radio messages made concerning the incident. Defendants object to both the request for internal affairs investigations and request for statements of witnesses and police officers on the following grounds:

Relevancy and Overbreadth

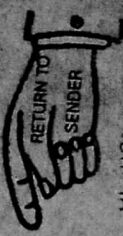
Defendants assert that the request is not relevant to any issues in this litigation, nor reasonably calculated to lead to the discovery of admissible evidence. Defendants further assert that the request is overbroad as to time, subject matter and officers, in that the request includes investigations which do not involve complaints against the officers named in this action and does not seek complaints regarding investigations with respect to use of excessive force in arrests by the named officers.

Under the Federal Rules of Civil Procedure, the parties may obtain discovery regarding any matter that is (1) "not privileged" and (2) "relevant to the subject matter involved in the pending action." Fed. R. Civ. P. 26(b)(1). Furthermore, "the information sought need not be admissible at the trial if the information sought appears reasonably calculated to lead to the discovery of admissible evidence." Id. The scope of discovery under the Federal Rules is extremely broad. A relevant matter is "any matter that bears on, or that reasonably could lead to other matters that could bear on, any issue that is or may be in the case." Oppenheimer Fund, Inc. v. Sanders, 437 U.S. 340, 351, 57 L. Ed. 2d 253, 98 S. Ct. 2380 (1978). Because discovery is designed to define and clarify the issues, it is not limited to only those specific issues raised in the pleadings. Miller v. Pancucci, 141 F.R.D. 292, 296 (C.D. Cal. 1992) (citing Oppenheimer, 437 U.S. at 351). Rather, the question of relevancy should be construed "liberally and with common sense" and discovery should be allowed unless the information sought has no conceivable bearing on the case. Miller, 141 F.R.D. at 296.

Although in general the party seeking to compel discovery bears the burden of showing that his request satisfies the relevance requirement of Rule 26, the court in Kelly v. City of San Jose, 114 F.R.D. 653, 667-68 (N.D. Cal. 1987), concluded that in the context of civil rights excessive force cases against police departments, plaintiffs may suffer great difficulties if courts impose demanding relevancy standards on them. Because it is unlikely that such a plaintiff would know the contents of confidential police files, the court suggests that it should be "sufficient for a plaintiff to show how information of the *kind* that is likely to be in the files could lead to admissible evidence." Id. at 667-68. The court reasons:

{162 F.R.D. 611} It does not seem fair . . . to demand that a plaintiff identify with particularity the information that is in confidential police files and demonstrate specifically how that information is relevant to his claims. **[A] judge should resolve doubts about relevance in favor of disclosure**, in part because she is not likely to understand the case as well as plaintiffs counsel, and thus is not likely to be able to foresee all the ways he might be able to use the information, and in part because the standard set forth in Rule 26 is so broad. Id. at 668.

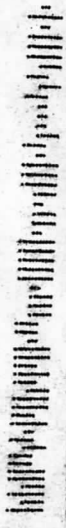
