# 19 MASS NAPUS Members Attend Final (?) Leadership Conference

The 2016 Leadership Conference was a success. MA was represented by 15 Postmasters, 2 Retirees and 4 guests.

Our Legislative Chair Robin Driscoll did a great job organizing the MA legislative meetings for us. We talked with our Congress Representatives' and Senators' aides about our concerns and NAPUS' position that postal relief legislation must address the Postal Service's prefunding issue by repealing or modifying the current prefunding requirement. It must encourage postal product and service innovation; postal pricing must accurately reflect the true cost of mail acceptance, processing and delivery; and the protection of earned Postmaster and retired Postmaster benefits. We reiterated that NAPUS opposes any legislation that would eliminate the current weightedaverage-premium contribution FEHBP formula and replace it with a fixed-dollar contribution indexed to the CPI. We oppose legislation that would replace the current formula for calculating the

retirement cost of living adjustment with the so-called chained CPI; legislation that would increase employees' retirement contributions; legislation that would change the federal pension computation formula from the current high 3 average to a 5 year average; and legislation that would eliminate FERS; and the elimination or reduction of the employer match to TSP. We also discussed the ongoing subject of the unfair treatment of CSRS annuitants known as the Windfall Elimination Provision (WEP) which reduces the Social Security benefits of workers who participate in pension plans from employment not covered by Social Security, such as CSRS; and the Government Pension Offset (GPO) which reduces a CSRS retiree's Social Security spousal or survivor benefits of the CSRS annuity.

We are very fortunate in Massachusetts, as our political leaders are on the same page as NAPUS Postmasters so we don't have to spend time discussing opposite views on the issues. This forum allows Postmasters a chance to thank them for their support and discuss any of their concerns or concerns of their constituents.

Unfortunately this may have been the last Legislative Conference held in this manner. The contract with the hotel expired and NAPUS has not signed with anyone else. It is my opinion that the Leadership Conference was the most important event held by NAPUS. The combined effort of MA NAPUS Postmasters to meet and discuss important Postal matters with our elected leaders was second to none and I hate to see this endeavor eliminated. In the future, as a state, we may have to organize something on our own. We will wait for guidance from the national office and will consider other options and the suggestions of the MA Executive Board.

# 2016 Model NPA Promises Many Improvements; 2015 NPA In Breakdown Lane Waiting For Repairs

Greetings Postmasters and Managers,

As I sit down to write this article, the Northeast area was hit by a snow storm, on the second day of spring, no less. Sometimes you just have to say to yourself, these are the things that are out of our control.

Speaking about things that are out of our control; do you think some of the goals in our PFP/NPA format are totally out of our reach and not within our control? It was such a frustrating year for most of the Postmasters that did not receive a raise under the broken NPA system but yet find themselves shut out of the mitigating steps with no recourse.

On March 11, 2016 our EXEC board met with Postal Service Human Resource Chief Jeff Williamson. Mr. Williamson sat with us for 90 minutes answering questions on NPA process. He admitted that the system needs upgrading in order to achieve its purposes. He laid out his plan with several key points. He believes in transparency in the system, and by achieving that he needs to upgrade the system in automation. This will allow Postmasters and managers to file mitigating circumstaces through the system with check and balances. Time sensitive for responding and equitable budgeting are also key factors that Mr. Williamson's team is working on.

This is all encouraging news for the 2016 NPA process. However, one cannot lose sight that we still have unfinished business with 2015 NPA problems and mitigating results that were not accepted by us. Our national leaders will continue to pursue and try to reach resolutions with the Postal Service to resolve the problems.

Our final NAPUS Leadership Conference has come and gone. It was a bittersweet feeling for most of the Postmasters and Managers that attended this Conference. For many years we came together and stormed the Hill. We walked the halls and asked our congressional leaders to listen to our postal issues. We bonded as one unit and together, we shared our thoughts and were able to lean on each other. We shared some joys and laughs; we were able to recharge our spirits and returned to our office rejuvenated.



I truly understand that we can still achieve our legislative goals by speaking with Congressional leaders back home. I also believe that having a Conference will bring all of us together and be more united. With the two Postmasters' organizations consolidating as one, it would be even more beneficial to have us together to voice and share our beliefs and thoughts, and we can all march to the hill once again.

## So, You've Decided To Become A Postmaster

### Seven Things You Should Consider Before Sliding Into The Big Chair

I worked in the craft for 10 years in a very busy associate office where I was exposed to many opportunities that weren't available at many other offices, and like many of you I was good at it. I then became a front line supervisor and for 10 years I availed myself to the district, learned many new skills and like many of you I was recognized for my contributions to the Postal Service. I read about leadership and continued to work on my people skills until I was ready to become a Postmaster, Or so I thought.

Sure, everyone says they want to sit in the big chair. But do they really? Before you step into a leadership position it is important you "get ready" for these seven things:

- 1- Get ready to be unpopular: As a fellow craft employee, most of your co-workers like you. You are a teammate and friend. As a front line supervisor you can soften some of the edges because the boss is making you do it. As the Postmaster, that won't be the case. The happiness of my employees is really important to me, probably too important at times. Let me be the first to tell you, not everyone will be happy and they will more than likely blame you.
- 2- Get ready to be questioned: As a fellow employee you could discuss or question the wisdom of new programs. As a Postmaster it is your responsibility to build alignment in your unit with the Postal Service goals. There is a huge difference and everyone knows more than you. People with fractions of the information will tell you what you are doing wrong. The questions will come from everywhere and you may not have all of the answers. Can you be confident enough in yourself to make it work? Can you stay strong and not allow outside influences to affect your ability to get everyone on board?
- 3- Get ready to have your character challenged: There will be programs rolled out by the Postal Service that don't appear to make sense and the information you receive will be insufficient to properly defend the onslaught of questions and doubt. You may be crunched for time and tempted to take shortcuts or lie about compliance issues. Don't do it. People are watching what you do, even more than what you say. If you decide to lead you will be attacked at some point. People will take shots at you either directly or more often than not, behind your back. How will you handle this?
- 4- Get ready for a different type of relationship with your employees: This may be the toughest challenge. As a clerk or carrier, typically, you have a very close relationship with your co-workers. However, as a co-worker or front line supervisor, you are not making the final decision. The leader, the Postmaster, needs to maintain a healthy distance. You will have to guard against getting too close; you have to make sure it doesn't appear that you are "playing favorites."
- 5- Get ready to deal with people who just don't get it: You will work around the clock trying to provide guidance and training for those you lead. You will sacrifice your personal time for others. And, there will still be some people who don't get it. You will strive to teach the life long lessons you can provide. It won't matter to some. This will hurt. Can you stay the course? Can you continue to try to do what's right despite of the criticism?
- 6- Get ready to have your family affected: Yes, your family will feel the impact of your leadership position. If you think becoming a Postmaster will be easier on you, don't let anyone fool you; this will be tougher on you and your family. The hours will be longer and you will seldom be completely "off" from the job. I cannot tell you how many times I've come home from a long day at work and tried to shift gears into dad and husband when I've received the "emergency" text or email. This absolutely impacts the family. Yes, dad is home but now dad is distracted.
- 7- Get ready to be on an island: There will only be a very, very select few people who know what you are going through. They are called Postmasters. Other people may think they know but they don't. You won't have the ability to "vent" to many people. You will have to find a core group of friends that will be there to support you, provide you with advice and help you through the difficult times. NAPUS!



## Fact or Fiction?

No, this title does not refer to the Presidential election. I am referring to meaningful Postal reform in Congress, including Financial Relief for the Postal Service. You may know that nothing new is happening in Washington. Still no appointees to the Postal Board of Governors; still no movement on the much discussed S. 2051, introduced by Sen. Tom Carper, D-DE, nor on S. 1742, the "Rural Postal Act of 2015", introduced by Sen. Heidi Heitkamp, D-ND. Both of these Senators, staunch supporters of the Postal Service, spoke to NAPUS members at the Leadership Conference in March. Sen. Heitkamp attended and spoke at the banquet.

Nothing yet, but not for lack of trying by Massachusetts NAPUS! Our dedicated group spent four busy days in DC at what may have been the last Leadership Conference as we know it. We attended training seminars, listened to the PMG and many other national figures, networked with Postmasters from across the country, and went to the Capitol to lobby for Postal Reform. On Tuesday, March 15, we visited the offices of 2 Senators and 9 Representatives from the House of Congress, to ask them, or their aides, the following questions:

- -Does the Representative/Senator believe the current Postal Service retiree health prefunding requirement is unfair?
- -Does s/he support the key elements of S. 2051?
- -Would s/he support a moratorium on further post office hour reductions?
- -Would s/he support an extension of the exigent rate adjustment beyond April 10?
- -Does s/he oppose an increase in the employee retirement contribution?
- -Would s/he support H.R. 711?

Tom Carper, D-DE and Rep. Elijah Cummings, D-MD, Ranking Member of the Committee on Oversight and Government Reform, joined Rep. Steny Hoyer, D-MD; Rep. Jose Serrano, D-NY; Rep Ted Lieu, D-CA; and Rep. Barbara Comstock, R-VA in expressing how valuable and necessary the Postal Service is, and complimented us on our dedication and leadership. Sen. Carper told us that "Leaders are people who build you up, not tear you down."

We hope that our leaders see the value in continuing the Leadership conference annually, in some form. We fear that visiting our Congressmen at home will not have the same impact.

We receive impact statements for each Congressional District to give to the Congress, so each Representative and Senator would know how many employees, offices, and routes are in their respective districts. ## ABC's For RCA Hiring

As the chairman of the state training committee, I am starting a new series of articles to be included in the Baystater. I will be asking for subject matter experts to share information that may be useful to us. I will be focusing primarily on information that may be useful to newly promoted Postmasters. And I will be asking for your input. If you are a newly promoted Postmaster, what is giving you a headache? If you are one of our seasoned pros, what are some of the questions you receive from the newbies? Email your topics to <a href="mailto:dbranga@hotmail.com">dbranga@hotmail.com</a>.

You may already be a SME (Subject Matter Expert) in some of the areas that will be presented in upcoming issues. Sugestions and shared knowledge is always welcome. I hope to cover a wide range of topics so that everyone can get something out of them. For this article, I want to talk about RCA hiring. I've had plenty of issues myself trying to navigate this process.

To begin with, Keith Dinsmoor is our point of contact for rural hiring. Last year, the hiring process for RCA's was changed by Shared Service. If you need an RCA, you need to send a complement request to Operations Support. Operations Support will send you back a confirmation or a denial letter and they will copy Keith. If approved, Keith will create the position and send you posters to display in your office announcing that you are hiring RCA's.

Once the position has been approved, Shared Services will then post the position in eCareer. They will monitor who applies and send out and also verify the background checks. Once the posting closes, they will send you a hiring list along with instructions and you can now begin calling applicants in for interviews. When you start your interview process, the background checks will have been ordered by Shared Services, but they may not be completed yet. Once you have completed the interviews, you

only have to submit 5 sheets of paperwork – the recruitment survey, the appointment affidavit, special agreement checks with inquiries (SACI), and the 2 pages of the employment eligibility verification. You then send those forms along with the application to Keith Dinsmoor. You do not have to send the entire package to him. Only send the package for those you want to hire. Included in the package from Shared Services that you received will be the instructions on how to answer the questionnaire on the interactive hiring list so they know who you are choosing.

To access the hiring list, log onto the blue page, click My Life, Jobs/E-Career, Review & Select and then click on Interactive Hiring list to access it. 

Now ALL retired Postmasters and Retired EAS can become members of our new organization. During our last NAPUS state convention this year we will vote to adopt a new set of Bylaws. We will decide on a National Secretary Treasurer for Retired Members to support and endorse prior to the National Convention. Also we will discuss our meeting in October. Because of changes to the Agenda our Retirees Meeting will be on Wednesday at 2:15 after the First Timers and Retirees luncheon. You will have an opportunity to win a door prize when you attend this meeting. Please plan to attend this years state convention and rekindle with old friends and make some new ones. On March 22, 2016 our National President of Postmasters Retired Clara McCullar testified before the House Ways and Means Subcommittee on Social Security. She urged Congress to support legislation introduced by Chairman Brady H.R. 711 "Equal Treatment of Public Servants Act". This legislation has 64 cosponsors and would modify the Windfall Elimination Provision (WEP) that unfairly reduces SS benefits to retired and disabled workers who receive annuities from employment not covered by SS. Postmasters under CSRS lose almost two thirds of earned SS benefits with WEP. She also urged support of H.R. 973 introduced by Representative Rodney Davis. This legislation would lessen the punitive effects of the Government Pension Offset (GPO) on the surviving spouses of many Social Security recipients. This is an example of your organization working for you. Show your support and see you on the Cape.




