Come to D.C. March 12-15 and make your voice heard! Both Houses of Congress will be in session.

This will probably be the last Legislative Conference, so I strongly encourage everyone to attend. It is the most valuable convention we have; meetings with legislators in the halls of Congress, grand ballroom sessions listening to Senators, Representatives, the PMG, and others, as well as time to visit the memorials and museums on Saturday and Sunday before the convention begins. AND you will be reimbursed for some or all ofyour expenses (airfare, early registration fee, and half the hotel room). How could it get any better? Fly home Tuesday evening after spending the day visiting your Congressmen at the Capitol; only two days of annual leave is necessary.

If you have any questions, contact me, or any member of the E-Board. Registration forms and a Conference Schedule, as well as hotel info, are on napus.org. The early registration fee of \$170 closes February 1, so register NOW! When making travel arrangements, fly to Reagan Airport (DCA). The Marriott Crystal Gateway is a short shuttle ride away.

The issues we will be discussing include Senator Tom Carper's postal relief bill (S. 2051), which has gained momentum by earning the bipartisan support of two key senators. This bill includes key elements that NAPUS has urged Congress to adopt, including retiree health pre-

funding, more accurate calculation of the pension liability, creating a more equitable means of setting rates, and marketing innovation. The bill also includes a moratorium on reductions of operating hours, clarification of managerial pay consultations, and access to the Merit System Protection Board process. The three management organizations have collaborated to promote legislation that furthers the priorities of our members. Also, NAPUS is concerned about post hour reductions imposed on rural and small town post offices. The concern focuses on two issues: the uncertainty of savings and the impact on customer service. In September, NAPUS filed comments with the Postal Regulatory Commission (PRC) relating to a Postal Service proposal to combine certain costs of small rural post offices with the costs of larger post offices. This consolidation would make it difficult to measure any cost savings attributed to hour reductions. In late November, the PRC issued a ruling, which will require the Postal Service to provide an explanation of the sampling used to calculate small post office costs, as well as other critical data. NAPUS believes that this data will provide a more complete record of the costs associated with the implementation of the hour reductions. The PRC requirements would enable the PRC, the Congress and the Postal Service to thoughtfully evaluate hour reduction data.

LEADERSHIP CONFERENCE – The 2016

Leadership Conference may very well be the last Leadership Conference to be held in this format and in Washington DC. If you have never attended, this is your chance. We will be learning about the NAPUS/League consolidation plans and gain information on how we will be developing a new set of bylaws that will govern chapters. The League will not be having their Legislative Forum this year and have been invited to attend ours. The conference will be held March 12-16, 2016 at the Crystal Gateway Marriott Hotel, Arlington VA. Only 2 days of annual leave are needed to attend this worthwhile event as MA Postmasters finish their business on Tuesday and fly home late Tuesday afternoon or early evening. Early online registration is available at www.napus.org at \$170 until Feb 1, 2016. Registration after Feb 1 is \$190 and does not guarantee a place at the MA Chapter table for the banquet. Hotel rooms are \$234 plus tax for single/double/triple and quad on a firstcome, first-serve basis until Feb 1, 2016. When calling, identify yourself as being with the NAPUS Leadership Conference.

The MA Chapter of NAPUS collects a \$2.00 monthly assessment fee with the monthly dues from all active Postmasters. This assessment fee money is used to help offset eligible expenses for Postmasters and Retirees to attend the annual Leadership Conference. The number of people that attend and the cost of eligible expenses determine the reimbursement amount. Last year attendees received reimbursement for early registration, transportation and shared hotel rooms. Obviously a hotel room shared with other MA Postmasters helps everyone with expenses. Washington DC is an exciting place. Don't miss this opportunity to meet with the senate and congressional representatives of Massachusetts to discuss postal issues that are important to all Postmasters and Postmasters Retired and to get up to date information about our jobs and the USPS from our NAPUS and Postal leaders.

2016 SCHOLARSHIP - The application is included in this issue and available online. The application must be postmarked by April 1, 2016. Please make sure your candidate submits all the required information. Remember all children, grandchildren, nieces, nephews and wards of active MA NAPUS Postmasters, Retired Postmasters and Associate Members are eligible to apply. 2016 MA STATE CONVENTION

Now that I have your attention, let me explain. Your MA NAPUS Executive Board voted to give some of your money away. Money from the MA Treasury, that is. Money that is possible because you pay dues. MONEY THAT EQUATES TO \$5,000! And the Red Jacket has agreed to reduce the room rates to \$129 a night, which is \$20 per night less than last year. Sounds like two great reasons to attend the MA 2016 State Convention to me.

It is time to mark your calendar and register for the 2016 MA NAPUS State Convention to be held at the Red Jacket Resort in South Yarmouth beginning at noon on Wednesday, May 25 and ending late morning on Friday May 27, 2016. CASH prizes will be given away at every event beginning on Wednesday at the luncheon, then at the District Managers' panel, at each of the training sessions, and at the BBQ during the dinner, the NASCAR races and the Auction. More CASH prizes will be given away on Thursday during the general business session and at the banquet. And on Friday there will be more CASH prizes at the general business session. The amounts will vary, but at the end of the convention, a total of \$5,000 will be awarded to attendees. You can win more than once during the convention, but only once at each event. The catch: YOU MUST BE PRESENT TO WIN AND MUST HAVE YOUR BADGE.

This particular State Convention is a very important event. At the

National Convention in Mobile AL in September 2015, NAPUS voted to dissolve the organization and form a new organization with the League of Postmasters. The new organization will be called United Postmasters and Managers of America (UPMA) effective November 2017. In the meantime, this vote requires both local chapters to develop new bylaws for the impending single MA Chapter of UPMA. The new bylaws must be voted on at the 2016 State Convention of both current organizations. A dual Executive Board to take effect on November 1, 2016 must also be formed. These are important changes and your MA NAPUS Executive Board is encouraging you to attend the 2016 State Convention to learn more about the upcoming changes to the organization. We are also inviting all MA League of Postmasters' members to attend.

The Red Jacket is in the heart of Cape Cod and is located right on the ocean with a beautiful beach, an outside and indoor pool complete with a hot tub. There is plenty to do on site, and not far from the resort there is fishing, golfing, sightseeing, shopping, dining and a lot more. As I already said, the room rate this year will be \$129 per room for up to 4 people. The phone number is 1-800-672-0500 and the Group Code is NAPUS. The cut-off for this room rate will be in May 6, 2016 so book early.

The registration form and hotel information is included in this

newsletter and also on our website at www.masschapternapus.shutterfly. com. Postmasters only who are attending the convention as a First Timer do not have to pay a registration fee if they register by May 1, 2016. For the rest of us (past attendees, OIC's, Associate members and guests), there is a reduced registration fee for registering early. So don't miss the chance to save some money! The Early Bird registration fee is \$95 if postmarked by April 1. The fee increases to \$115 for postmarks after April 1 and then the fee increases to \$125 for postmarks after May 1 and for walk-in registrants. The Retirees registration fee is \$90 if postmarked by May 1 and \$110 after the May 1 deadline. Due to increased convention costs such as meeting space and supplies, there will be a Daily Business Session Fee of \$20. This fee is for persons attending only the business and/or training sessions and does not include any meals. Anyone deciding to stay for meals would have to pay the individual meal costs outlined on the registration form. Plan ahead and take advantage of the Early Bird Special. We will follow the same agenda as the last couple of years as it seems to work well for most people. Keep in mind that registration opens at 8:00 AM Wednesday morning with an E-Board meeting at 10 AM. Chapter events begin with greeting the PAC'n A Cure participants late morning in front of

the hotel, followed by a luncheon for everyone at 12:00 PM which leads right into the District Managers' panel in the same room. Two training sessions will be held from 2:15-3:00 and then again 3:15-4:00 PM and the First Timers meet and greet will be 4:15 PM on Wednesday. The First Timers' Committee is gearing up to ensure that all Postmasters new to the convention navigate the convention with ease and have a great time. I have yet to find a first timer that has not thoroughly enjoyed themselves and made many new friends. The BBQ, raffles, NASCAR races and auction will be held in the evening.

The perfect place to renew and begin friendships is at the BBQ the first night. This is followed with the very serious NASCAR races and then our ever important scholarship auction. The auction is the biggest fundraising event to support the MA Scholarship Program. PLEASE BE SURE TO BRING A NEW ITEM TO THE AUCTION on Wednesday. Also, please encourage Postmasters who cannot attend the convention to donate an item for the auction and volunteer to bring it with you or find someone who is going so they can bring it.

Training sessions being considered include the electronic PS Form 150 and a retirement seminar. More information about the training sessions will be posted on the website as it becomes available.

The general business session will begin at 8:15 AM on Thursday with the opening ceremony, followed by a speaker to be determined, elections for President and Vice-President, any proposed bylaw changes, and reports from your State Executive

Board Members. And then some long needed free time in the afternoon before the banquet. Play golf, go fishing, go shopping, go out to lunch, or just relax with some old and new friends.

Newly elected officers will be sworn in at the banquet and the 2015 Postmaster of the Year Award will be presented. We will also be inviting the scholarship winners and their parents to attend the banquet for a presentation. Of course, we understand that many of the kids can't join us due to senior activities or jobs.

The Friday business session will include a continental breakfast, one guest speaker, and any unfinished business if needed. We should be able to close the convention around 10:30 AM allowing everyone an early start home, a day to enjoy on the Cape or an early return to their office. Hopefully many of you will be leaving with \$\$\$\$\$in your pockets.

If you are interested in running for the position of either President or VP/Legislative Chair, you can contact the incumbents, State Constitution and Bylaw Chair Chuck Nichols, or any member of the State Executive Board for more information about the positions. You can also view a full list of duties and compensation outlined in the bylaws posted on our website mentioned above.

Please take the time to nominate a NAPUS Postmaster for 2015
Postmaster of the Year. I'm sure you know someone who is deserving of this award. Take a few minutes to complete the nomination form and submit it with a narrative explaining why your candidate deserves to be selected. The Postmaster does not have to be present at the convention to

be awarded.

Don't forget to put an ad in the Convention Ad Book and ask your family and friends to purchase an ad too. This is another fundraising effort to support the MA Scholarship Program. Submit a business card, a picture of your kids or grandkids, a funny picture of yourself and your friends or an unsuspecting peer. Most anything is acceptable. If you can't think of a caption for your picture or you want Editor Jerry Robertson to design an ad for you, just send the check with a note and he'll take care of it for you, but please purchase an ad to support the kids and entertain your fellow members.



Election Of Officers At State Convention

ARTICLE 5 – ELECTION OF OFFICERS

As stated in the MA Bylaws, the election of Officers shall take place during the Annual Convention of this Chapter and it shall require a majority of the vote cast to be elected. In the event of a tie vote, the Executive Board shall decide the election; each member will cast one vote. All elections must be held by written ballot, with the exception of an unopposed candidate who may be elected by the casting of one vote by either the President or the Secretary/Treasurer. Any member of this Chapter, in good standing, may nominate a candidate from the floor for any elective office in addition to those selected by the Nomination Committee.

Elected officers shall be installed following election during the State Convention and their term of office and responsibilities shall commence on the first day of the month following the NAPUS National Convention.

This year the position of President and VP/Legislative Chair are up for election. The duties and responsibilities of these positions are outlined in the MA Bylaws as follows:

PRESIDENT - The President shall be the Executive Officer of this Chapter. He/she shall preside at all meetings, and shall call special meetings when requested as stated in Article 10, Amendments Section 4, Special Meetings; shall appoint all committees provided herein and all other committees not in conflict herewith and necessary for the proper conduct of the business of this Chapter, and in general perform each and every act and such other duties as may appertain to this office. The President must be an active member as described in Article 3, Section 1 (Active Members. Every Postmaster, Acting Postmaster, Officer-in-Charge and Postmaster Relief in the Commonwealth of Massachusetts shall be eligible for membership in this Chapter and may become members thereof upon the acceptance of their application for membership and payment of membership dues.).

VICE-PRESIDENT/LEGISLATIVE CHAIR - Due to an excused absence of the President, the Vice President shall preside at all meetings conducting Chapter business. The Vice President shall serve the Chapter as requested by the President and/or Executive Board. He/she shall serve as State Legislative Chairperson. In the event of the President's resignation, removal or death, the Vice President shall assume the duties of the President immediately and serve in that position until the office is filled by the Executive Board as stated in Article 7, Executive Board. The Vice President/Legislative Chair must be an active member as described in Article 3, Section 1 (Active Members. Every Postmaster, Acting Postmaster, Officer-in-Charge and Postmaster Relief in the Commonwealth of Massachusetts shall be eligible for membership in this Chapter and may become members thereof upon the acceptance of their application for membership and payment of membership dues.).

It is also important to mention that any changes to the State Constitution must follow Article 9, which states, "This constitution may be altered or amended at any meeting of the Chapter by a two-thirds (2/3) vote of the members present. All proposed amendments must be submitted in writing and signed by any member by sending it to the Secretary/ Treasurer and the Chairman of the Constitution/Bylaws Committee at least thirty (30) days before the Annual Meeting."

The National Credit Union Administration is warning consumers about a telephone scam in which consumers are contacted by a caller claiming to work for NCUA and asking for personal and financial information. The caller tells the consumer her or his credit card or debit card has been frozen or blocked. The caller then asks for the consumer's Social Security number, account number, date of birth and home address to supposedly verify the information.

Unfortunately there are a lot of dishonest people out there trying to steal personal information. The best advice is to stay vigilant and protect your personal information.

Keep in mind that if you don't repay the loan, the lender can take your collateral and sell it to recover the funds owed.

56 Facts About Blood and Blood Donation One for each day between your blood donation!

- 4.5 million Americans would die each year without lifesaving blood transfusions.
- 2. Approximately 32,000 pints of blood are used each day in the United States.
- 3. Every three seconds someone needs blood.
- 4. One out of every 10 people entering a hospital needs blood
- 5. Just one pint of donated blood can help save as many as three people's lives.
- 6. The average adult has 10 pints of blood in his or her body.
- 7. One unit of blood is roughly the equivalent of one pint
- 8. Blood makes up about 7% of your body's weight
- 9. A newborn baby has about one cup of blood in his or her body.
- 10. The average red blood cell transfusion is 3.4 pints
- 11. Blood fights against infection and help heal wounds, keeping you healthy.
- 12. There are four main blood types: A, B, AB, and O. AB is the universal recipient and O negative is the universal donor.
- 13. Blood centers often run short of type O and B blood.
- 14. Shortages of all types of blood occur during the summer and winter holidays.
- 15. If all blood donors gave 2 to 4 times a year, it would help prevent blood shortages.
- 16. If you began donating blood at age 17 and donated every 56 days until you reached 76, you would have donated 48 gallons of blood.
- 17. About three gallons of blood supports the entire nation's blood needs for one minute
- 18. Blood donation takes four steps: medical history, quick physical, donation, and snacks.
- 19. The actual blood donation usually takes less than 10 minutes. The entire process, from when you sign in to the time you leave, takes about 45 minutes.
- 20. Giving blood will not decrease your strength.
- 21. You cannot get AIDS or any other infectious disease by donating blood.
- 22. Fourteen tests, 11 of which are for infectious diseases, are performed on each unit of donated blood.
- 23. Any company, community organization, place of worship or individual may contact their local community blood center to host a blood drive.
- 24. People donate blood out of a sense of duty and community spirit, not to make money. They are not paid for their donation.
- 25. Much of today's medical care depends on a steady supply of blood from health donors.
- 26. One unit of blood can be separated into several components (red blood cells, white blood cells, plasma, platelets, and cryoprecipitate).
- 27. Red blood cells carry oxygen to the body's organs and tissue.
- 28. There are about one billion red blood cells in two to three drops of
- 29. Red blood cells live about 120 days in the circulatory system.

- 30. Platelets help blood to clot and give those with leukemia and other cancers a chance to live.
- 31. Apheresis is a special kind of blood donation that allows a donor to give specific blood components, such as platelets.
- 32. Donated red blood cells must be used within 42 days of collection.
- 33. Donated platelets must be used within five days of collection.
- 34. Plasma can be frozen and used for up to a year.
- 35. Plasma is a pale yellow mixture of water, proteins, and salts.
- 36. Plasma, which is 90% water, constitutes 55% of blood volume.
- 37. Healthy bone marrow makes a constant supply of red cells, plasma and platelets.
- 38. People who have been in car accidents and suffered massive blood loss can need transfusions of 50 pints or more of red blood cells.
- 39. The average bone marrow transplant requires 120 units of platelets and about 20 units of red blood cells. Patients undergoing bone marrow transplants need platelets donations from about 120 people and red blood cells from about 20 people.
- 40. Severe burn victims can need 20 units of platelets during their treatment.
- 41. Children being treated for cancer, premature infants, and children having heart surgery need blood and platelets from donors of all types.
- 42. Anemic patients need blood transfusions to increase their iron levels.
- 43. Cancer, transplant and trauma patients and patients undergoing open-heart surgery require platelet transfusions to survive.
- 44. Sickle cell is an inherited disease that affect more than 80,000 people in the United States, 98% of whom are of African descent. Some patients with complications from severe sickle cell disease receive blood transfusions every month up to 4 pints at a time.
- 45. In the days following the September 11th attacks, a half a million people donated blood.
- 46. Females receive 53% of blood transfused; males receive 47%.
- 47. 94% of all blood donors are registered voters.
- 48. 60% of the US population is eligible to donate only 5% do on a yearly basis.
- 49. 17% of non-donors cite "never thought about it" as the main reason for not giving, while 15% say they're "too busy". The #1 reason donors say they give is because they "want to help others"
- 50. After donating blood, you replace these red blood cells within 3 to 4 weeks. It takes eight weeks to restore the iron lost after donating.
- 51. Granulocytes, a type of white blood cell, roll along blood vessel walls in search of bacteria to eat.
- 52. White cells are the body's primary defense against infection.
- 53. There is no substitute for human blood.
- 54. It's about Life.
- 55. Since a pint is a pound, you lose a pound every time you donate
- 56. Anyone who is in good health, is at least 16 years old, and weighs at least 110 pounds may donate blood every 56 days.

Thank you Massachusetts Postmasters! As of 12/16/15, you have donated over \$5000 to your PAC!!! That money goes directly to lobbying efforts keeping postal issues alive.

As I tallied up the total PAC contribution for 2015, one thing that really stood out was

the surprisingly low number of donors. Only 64 Postmasters, and that includes the retirees, are regular contributors to PAC. There are over 700 active members of our state NAPUS chapter. If all of you only had a one time contribution of \$10 PER YEAR, we would raise over \$7,000. I can't figure out why more Postmasters aren't contributing to PAC. Do you think there aren't any legislative issues that will affect you? Do you think there won't be more closings? POStPlan-like changes in the future? Do you all believe that Congress will never touch our retirement system or the amount of employee contributions to your health care? Think again! All these things and more are constantly coming up in Congress. The only way to

maintain or improve your benefits and possibly your career (imagine being excessed out of a job because they consolidated post offices), is to lobby Congress. To lobby Congress, we need money. We are no different than any other special interest group. Money talks and BS walks. Break out that purse, that wallet...dig thruough the seats of the couch and car and donate a measly \$10 today to PAC. Heck, a quick coffee and breakfast sandwich runs you \$7. And that only lasts you a few hours. Donating to PAC will last your career and your retirement. If you haven't donated because nobody asked you, well I'm asking now! Please donate.
