American People,

My last paper of April 10<sup>th</sup> grew too long therefore I reserve to this one to speak further on the subject of our dying liberty. These oppressive laws disarming the citizen militia and being upheld by our enemy's courts are subversive of freedom and inconsistent with the heritage of the American Revolution. The melancholy truth is that these disarming laws are an omen to our approaching slavery. The founding generation made it abundantly clear with their caveat to us, their posterity, that whenever government plans to invade the rights and liberties of the people, they always attempt to destroy the militia.

There are two forces in play here: Liberty based on the laws of nature versus power based on human greed and self-interest. One wants more freedom and self-government and the other wants more power and control. In all contentions between liberty and power, power is always the aggressor. Government always tries to increase its power under the pretext of public safety or public good. These latest militia rifle bans have altered the balance between liberty and power. So, here we go again, on the road to revolution. There must certainly be a vast fund of stupidity in human nature, or else men would not be caught as they are, a thousand times over, by the same snare, and while they yet remember their past misfortunes, go on to encourage the causes to which were owing to produce their ensnarement.

The moneyed class has the power to control the government and therefore always proceed "legally" in their tyranny. You see, these real, great and general attacks on our natural rights, are defended by giving it a good name, by which he who commits it is protected; their violence, fraud and oppression, may be committed with security, if they are called "laws," and the detestable authors of them are not only safe, but esteemed, if they are but called law makers. What this vulgar scum doesn't appear to realize, is that it is the glory of honest men to trample bad laws underfoot with contempt; and it is equally our glory to protect ourselves in our lawful natural rights when those who rule the law fail to protect our rights. It is precisely because we are disloyal to these traitors that we are loyal to the American People. Plainly stated, these militia rifle bans are injustice masquerading in the form of law.

It is further evident to me that these disarming laws have a detrimental effect on the political functions of the People. These include: 1) increased reliance on government and tolerance of increased police power; 2) repressive actions by government becomes easier and more likely; 3) helps prevent opposition to government; 4) lessens pressure on government to reform; and 5) promotes selective enforcement against dissidents. Another twofold influence at play are natural law versus man made statutory or positive law. Instinct is in every living creature that comes from the pull of natural law. The best known and superior instinct is the will to survive or self-preservation. The law of self-preservation is eternal and unchanging. The yearning for liberty is an appetite so strongly implanted in the nature of all living creatures that even the strongest instinct of self-preservation seems to be contained within it. From these two natural instincts springs the right to keep and carry arms. This right is bestowed upon us by nature simply because we were born, not by any man-made constitution. These are no longer propositions as they were at the time of the American Revolution, they are now self-evident facts. Natural law dictates the limits on Government actions.

On the other fold you have man-made statutory law which can never annul the laws of nature. When government uses statutory law to impose constraints upon our natural rights and liberty beyond those necessary to carry out and enforce the social contract (constitution) between the People, then the People need not obey. Though adhering to these statutory laws carries an objective air of propriety, such a passive tactic serves the interests of those in power. The doctrine of obedience to properly constituted authority was invented by tyrants; and the purest essence of tyranny is being forced to obey laws that one's

When liberty is threatened, all share the responsibility for defending it. It is in everyone's self-interest to do so. If we

do not stand by liberty to the shedding of the last drop of blood in our veins, we will be disgraced forever and rightly deserve the fate of grovelling cowards. If your not willing to die for your rights — you have no rights! And if we do not have the fortitude enough to face danger, in a just cause, we are cowards indeed, and must in consequence of it, be slaves of a tyrannical socialist government.

It goes without saying, as freemen and women we will not allow ourselves to be legislated out of our natural rights. The government uses what they call "laws" to prevent the citizen militia from properly arming itself; labeling all who oppose it outlaws, when in fact we are soldiers in a just cause rather than outlaws. If we were to obey such "laws," the people would by law, be bound to be an accessory to their own ruin and destruction, which is inconsistent with the first principles of common sense.

Did our forefathers fight the revolution in vain? If the current struggle can be equated to the American Revolution, then the federal government is our Britain. If the federal government's Supreme Court upholds these militia rifle bans, it will have called the violence upon itself. As sure as the forces of nature express obedience to the laws of gravity we must obey the true principles of liberty and natural right, and resist at all costs.

hold together, and defend themselves against this detestable scheming of the government.
