

In Support of Schaeffer Cox #9. May 21, 2017

It's important to develop a timeline to understand why Joseph W. Bottini was dropped from sight on the Schaeffer Cox case. (I am sure Bottini continued behind the scene) I start the time line with the investigation of the corrupt conviction of Senator Ted Stevens. At a time, when my friend Schaeffer Cox was making a public presentation to a national audience.

April 7, 2009- Judge Emmet G. Sullivan orders an investigation into the corrupt conviction of Senator Ted Stevens. Where is/are the problem(s) in the DEPARTMENT OF JUSTICE?

November, 2009. Citizens throughout the nation elect delegates to the Third Continental Congress. Schaeffer Cox was elected from Alaska. He is seen as a great orator. I concur. A young man much wiser than his years. He becomes well known throughout, what is often referred to, as the "Patriot Movement/Militia Movement." March 10, 2011. Schaeffer Cox is arrested.

March 17, 2011 inditement brought against Schaeffer Cox. Joseph W. Bottini is the first DEPARTMENT OF JUSTICE attorney mentioned in the inditement. He is on a list of the attorneys involved in the Schaeffer Cox case.(both sides) He is mentioned as possible lead attorney for the DEPARTMENT OF JUSTICE, in regards to the case against Cox.

May 4, 2011 Joseph W. Bottini files "Notice of Attorney Appearance." A legal document (filed in US District Court-Alaska) stating he is "co-council for the United States of America" in the Schaeffer Cox case.

November 14, 2011- Schuelke Report exposing the corrupt behavior of Joseph W. Bottini is presented to Judge Emmet Sullivan. Not to the public. Documentation is for the judges eyes only.

February 15, 2012- From Cox's inditement to this date there are several documents filed in court dealing with the Cox case. Every one mentions Joseph W. Bottini as co-council. However, this was the last time Joseph W. Bottini is ever mentioned in the Cox case. I am sure he continued to direct the case outside public view. For he was an integral part in bringing charges against Schaeffer.

March 15, 2012 Judge Sullivan allows the public release of the complete Schuelke report. Amazing, nothing redacted. Showing all the names and information of evil doer Joseph W. Bottini.

March 28, 2012, The Judiciary Committee (US Senate) invited Mr. Schuelke to speak about his report. (See the attached.)

March 31,2012. Another legal document filed in US District Court-Alaska. (Regarding the Cox case) It is the first time Joseph W. Bottini is not mentioned in the DEPARTMENT OF JUSTICE

filings in Cox's case. The DEPARTMENT OF JUSTICE did not want the corrupt behavior of Joseph W. Bottini exposed during Cox's trial.

They say a picture is worth a thousand words. A video must be worth a million. Please watch the hearing, in the Senate, regarding Mr. Schuelke oral testimony concerning Joseph W.
