Here is what we know about Joseph W. Bottini.

He is an expert attorney within the DEPARTMENT OF JUSTICE since his novice entry in 1985.

He help develop the case against Senator Ted Stevens. It is well documented he intentionally withheld evidence that Senator Stevens was telling the truth.

He also developed the cases against Alaska’s State Senators Peter Kott and Victor Kohring. Because evidence was withheld in those cases, their convictions were overturned.

The attached also includes Joseph W. Bottini’s legal response through his attorney. Within it, Mr. Bottini’s attorney states-

“Assistant United States Attorney (“AUSA”) Joseph Bottini acknowledges that he played a role in the resulting discovery violations, and he will always live with a profound sense of personal regret for the effect those violations had on the integrity of the Stevens trial and on the Department he loves and has spent his entire career serving.”

“Personal regret”? Hogwash! Nicholas Marsh demonstrated personal regret. He committed suicide. Marsh’s only fault was his poor supervisory role in the Stevens

trial. I only wish he had accepted his possible punishment (from the DOJ) for his failed supervision of the likes of evil doer Joseph W. Bottini.

Rather, Marsh had a personal regret he could not live with. So a young life was cut short because those he trusted set him up for failure.

Joseph W. Bottini did not nor does not accept any “personal regret.” For if he did he would not have appealed his 40 day financial punishment. Next time I will post the judge's decision on the punishment given to discipline evil doer Joseph W. Bottini.

## **Comment Of Senator Patrick Leahy On The Release Of The Department Of Justice OPR Report On The Stevens Prosecution**

“I thank Attorney General Holder for providing this report to the Judiciary Committee. I will thoroughly review this report on allegations of prosecutorial misconduct by Justice Department attorneys and investigators in the trial of the late Senator Ted Stevens. I plan to hold a hearing on June 6 to learn what steps the Department is taking to ensure sure that what happened in the Stevens case does not happen again, regardless of the prominence of the defendant. In order for our justice system to work, prosecutors must adhere without fail to the directive to seek justice for all parties, not just convictions.”
