

Hello world,

The one thing that seems to be missing from everyone's understanding of my case is the context of the conversations that FBI informant JR Olson recorded. So let me explain it real quick:

For years the "investigation" had tried unsuccessfully to get me to agree to go on a shooting spree in Fairbanks. They wanted me to do something horrible that would discredit the Liberty Movement and give the cops a chance look like heroes for stopping me, rather than the corrupt criminals they actually are. But the fact of the matter is that our grass roots organizing to expose corruption was working great and we had no reason at all to change it.

The cops knew this so they set out to give us a reason. Here's how.

One arm of the "investigation" was making threats and taking aggressive action outside of policy to threaten my children. They were hunting my young family down trying to scare and provoke us with their underhanded efforts to snatch our 1 1/2 year old son. They were stalking us around town. They were going to Ft. Wainwright and bragging about how they were going to kick in our door over a bogus child neglect complaint that THEY made up just so they could get a chance to shoot me and -- as they put it -- "fix the Schaeffer Cox problem." I was made painfully aware of all of these threatening actions as they were unfolding in the summer of 2010. The good and honest military Police even gave us affidavits, which we still have.

While my family and I were having our lives threatened by these openly corrupt cops, the other arm of the "investigation" sent in JR Olson to continually remind me of the threat to the lives of me and my family. Day after day he constantly hounded on it; "what are we going to do if they come and start kicking in doors and killing us and taking the children? I mean these are our children we're talking about here. What would you do as a father if you had to to keep your kids safe from these corrupt tyrants? And Bill Fulton said to remind you that if you are such a coward that you won't even stand up to defend your own children, he's going to come to Fairbanks and kill you himself and then get the revolution started. He says these tyrants have gone too far with going after your children and it's time for us to do something." (Don't forget that the guy asking these questions works for those "corrupt tyrants" and is wearing a wire for them. Bill Fulton is also an FBI provocateur. And I didn't know any of this at the time.)

This is the context of those recordings. Put yourself in that situation. Ask yourself, what might you say in that situation in what you thought was the privacy of your own home?

Even in this no-win situation that was fabricated by a desperate gang of crooked cops hell-bent on getting rind of me any way they had to, I STILL said and did the right thing, the smart thing, and the lawful thing. My response was consistently as follows; "Look I know these cops are dangerous. I know they are threatening my children. You are right about that. Okay, I get it!! I really do. There is no question that as a father I would be well within my rights morally -- and probably even legally -- to hang every last one of these bastards. But that's a fight I can't win. None of us can. Nothing good would come from it. It would be a fruitless gesture, and it would hurt my family AND YOUR FAMILY TOO. Even though I'd like to go lop some heads off for trying to harm my family, I just can't do that. EVEN THOUGH IT MIGHT BE JUSTIFIED BECAUSE OF WHAT THEY ARE DOING. But I have to do what's best for my family. And what's best for my family is to get in the back of a truck and get smuggled out of the country so the cops can't kill me or my family, and so Bill Fulton can't kill me for not killing the cops; who are trying to kill me. THIS IS NUTS! Me just leaving, walking away and losing everything; that's what has the brightest future for my family. And that's what I'm doing. I don't have hatred toward these corrupt cops. I would forgive them and be very redemptive towards them, if they'd leave me alone. I don't hate them. Sure, I'd do whatever I had to to protect my children -- even shoot them in the face -- but right now the best way for me to protect my children is to get out of the country to avoid a fight we CAN NOT WIN! These cops -- and frankly the whole government -- will collapse under the weight of their own sins soon enough. We need to just sit back and watch. That's why time is on our side and why it's in our best interest to avoid a fight."

That, my friends, is the context of the recordings; the FBI was threatening my children, then sending in a guy with a wire to

ask if I would protect my children or not. I said YES! I'M PROTECTING MY CHILDREN BY GETTING OUT OF THIS COUNTRY THAT'S LOST ITS MIND!
