Moving to Overthrow the Electoral College

Okay for all of you folks who may have bought into President Obama's promise that he would fundamentally change the United States of America, here is a new development, actually worse than Obamacare. It is the changing of the election process for the next president.

As you all probably know the president is elected via the Electoral College requiring 270 votes. There is a movement to change that requirement to electing the president by a majority of the popular vote. So a 51% vote of the popular vote will determine the election. Nineteen states have already elected to this, without a single mention of this in the national news media, not by congress, at least not by my representatives in PA.

Add to this situation a movement in CA to allow non-citizens to vote. The constitution does not require a voter to be a citizen. The eligibility to vote was left to the states. Arkansas was the last state in the union to require voters to be U.S. Citizens, and that was in 1926. Prior to 1926 some states did allow non-citizens to vote. The movement in CA is promoting that non-citizens are being dis-enfranchised from the voting process. So we can expect illegal aliens to start voting if CA, or any other state, changes their voting eligibility rules to allow non-citizens to vote.

Now let's add in President Obama's latest mantra supporting the democratic position against voter id. The result will be an open season for voter fraud, and without doubt in favor of the democratic party. Yes, the country will be fundamentally changed – single party rule in the United States much like Russia, China, North Korea, Iran, Venezuela, etc.
