## Pricetown Rifle and Pistol Club, Inc. Operating Rules

- 1. All members shall comply with Federal, State, Local and club laws and rules while on Club premises. Violations may be grounds from termination of membership
- 2. All members shall make safety their top priority while on Club premises
- 3. All members shall comply with specific range (Trap, rifle and pistol) rules
- 4. The Club, board, members, etc. are not responsible for anyone injured on Club premises. An individual using Club premises does so at his own risk and assumes all responsibility for injuries to a person or property caused by or to him
- 5. Members only are permitted to use Club ranges. Pricetown Rifle and Pistol Club, Inc. assumes No Responsibility for injury or damage due from use or misuse
- 6. Members may be asked to identify themselves by presenting their current membership card while using club facilities and must carry membership card when using ranges
- 7. Everyone must sign in log book printing name and entering membership type
  - a. A group roster may be submitted in lieu of individuals signing log book
- 8. Do Not Handle Firearms when someone is down range
- 9. Actions on firearms that are not in use must be open
- 10. Safety violations may result in expulsion from the club
- 11. An individual under 16 years of age may not use the range unless accompanied by a voting eligible member 18 years of age or older
- 12. Appropriate personal protective protection including but not limited to eye and ear protection are required at all times while on any range
- 13. Discharge of armor piercing or tracer ammunition is prohibited
- 14. Appropriate firearms must be used on each range
- 15. FULLY AUTOMATIC WEAPONS use requires board approval
- 16. Being intoxicated, use or possess an intoxicating beverage or controlled substance on the ranges are prohibited
- 17. Ranges are open from 8 a.m., prevailing time, until sunset daily
- 18. Range may be reserved for exclusive use by an organized groups such as Berks Pistol. An organized group desiring to reserve the range shall make necessary arrangements through approval by board of directors
- 19. An individual may not use the range when in use on days when it is reserved by an organized group. Check web site calendar for group usage.
- 20. Courtesy expected when using Club facilities and ranges
- 21. Avoid shooting up the framework used to hold the backstop material
- 22. Paper, clay bird or cardboard targets only. No explosive or incendiary targets permitted. Targets must be elevated off the ground to avoid ricocheting

- 23. Destruction of Club property will not be tolerated
- 24. An individual or an organized group using the range is responsible for keeping the area clean and free of debris, and may not discard, deposit, leave or throw litter except in approved refuse containers. Range users shall remove targets from range backboards when shooting is completed and prior to leaving the range
- 25. TRESPASSERS OR ANY MEMBER INTENTIONALLY DAMAGING ASSOCIATION PROPERTY WILL BE PROSECUTED TO THE FULL EXTENT OF THE LAW, AND WILL BE RESPONSIBLE FOR THE COST OF ALL REPAIRS. PLEASE REPORT ANY UNINTENTIONAL DAMAGE TO THE FACILITIES AS SOON AS POSSIBLETO ANY OFFICER

## Membership Types

## Voting

Voting members in good standing are entitled to all club benefits and are able to vote on club matters at regularly scheduled meetings.

- Regular Annual Member
- Life Member

## Non-Voting

Non-Voting members in good standing are entitled to all club benefits, however are not able to vote on club matters. Failure to follow rules can result in expulsion of sponsoring member.

- Junior Annual Member
  - Must be sponsored by a Regular Annual or Life member. May only use club facilities while a voting member is present. There will be an additional fee to Regular Annual or Life member fee annually of \$5.00 to include youth 12-under 18.
  - The term will expire at the normal club closing time on last day of club annual membership.
- Family Annual Member
  - Must be sponsored by a Regular Annual or Life member. May only use club facilities while a sponsoring member is present. There will be an additional fee to Regular Annual or Life fee annually of \$5.00 to include spouse/significant other/children under 16.
  - The term will expire at the normal club closing time on last day of club annual membership.

- Pending Member
  - Must be sponsored by Regular Annual or Life member. May only use club facilities while a sponsoring member is present.
  - You must legibly fill out the entire Membership application form and pending membership card and pay current new member fee prior to or upon arrival of first visit. Do not do anything including unloading vehicle, setting targets or walking on property before filling out and paying for membership. The membership application form and fee must be deposited in designated box or presented to an authorized membership processing member.
  - The term will expire at the next club meeting after the membership applications are processed.
- Group Limited Term Member
  - Must be sponsored by a Regular Annual or Life member. May only use club facilities while a sponsoring member is present. There will be an additional fee of \$1.00 per group participant for the term of the membership. The term will be approved by the board as part of approving group membership process.
  - A group roster must list all group members present and may be used in lieu of individuals signing log book
  - The term will expire at the normal club closing time on last day of approved term.
- Active Military Annual Member
  - Must be sponsored by a Regular Annual or Life member. There will be an additional fee to Regular Annual or Life fee annually of \$1.
  - The term will expire at the normal club closing time on last day of club annual membership of year active duty is terminated.
- Day Limited Term Member
  - Must be sponsored by a Regular Annual or Life member. May only use club facilities while a sponsoring member is present. There will be an additional fee of \$1.00 per person per day of the membership.
  - You must legibly fill out the entire Day Membership application form and Day Membership card and pay for membership upon arrival. Do not do anything including unloading vehicle, setting targets or walking on property before filling out and paying for daily membership. The membership application form and fee must be deposited in designated membership box.
  - The term will expire at the normal club closing time on the day of membership.
  - No individual may register for more than three (3) Day Limited Term memberships per year.
