1. No sharing of vendor space 1 exhibitor per booth.
2. **If you have a vehicle on site during the show, it must fit inside your allotted space.** You may need to purchase additional spaces to accommodate your vehicle, trailer, display, etc.
3. No vehicles will be allowed to enter or exit for any reason when the event is open to the public.
