We appreciate the trust you place in us to help those in need around the world. We value your privacy and understand concerns you may have about personal information provided during your use of this website.

Privacy Policy

Thus, the privacy policy of *4 A Life Foundation* stipulates that the directors and employees of the organization can have access only to information that you voluntarily give us via email or other direct contact. We will not share your information with any third-party outside of our organization, other than as required to fulfill your request or comply with law enforcement agencies/personnel in conjunction with a legal process. We will not ask for your social security number; nor should you provide this to anyone who reportedly asks on behalf of *4 A Life Foundation*.

Unless you ask us not to, we may contact you in the future to inform you of upcoming missions, medical projects, featured children needing sponsorship, or changes to this privacy policy.

Your Access to and Control Over Information

Protection of Children

It is the policy of *4 A Life Foundation* to adhere to the restrictions set forth by the Children's Online Privacy Protection Act of 1998 which requires web site operators to avoid requests of personally identifiable information from anyone under the age of 13 in the absence of verifiable parental consent.
