**WHAT:** House Bill 7125 - AN ACT CONCERNING A STUDY OF THE PATIENT PROTECTION AND AFFORDABLE CARE ACT- To require the Insurance Commissioner to conduct a study regarding the impact of ANY CHANGES to the Patient Protection and Affordable Care Act (Obama Care) on this state. <https://www.cga.ct.gov/2017/FC/2017HB-07125-R000231-FC.htm>
