PROPOSED CHANGES TO MESQUITE CLUB BYLAWS 2016—PAGE 1

ARTICLE III. MEMBERSHIP

Section 3: CLASSIFICATION

Proposed Change: Add new sections "B" and "C".

- B. An Honorary Member retains all the rights, privileges and obligations of an active member but is not required to pay annual dues. Only members who were designated "Honorary" prior to 2011 shall hold this classification.
- C. A Sustaining Member is a member who has held membership in Mesquite Club for at least 35 years, has reached the age of 70 years, and requested a Sustaining Member classification prior to 2011. A Sustaining member retains all the rights, privileges and obligations of an active member but is required to pay only one-half the current annual dues.

Rationale: To clarify the status of current Honorary and Sustaining members. Honorary and Sustaining membership classifications were a part of our bylaws prior to 2011, and even though these classifications were removed, there are still members in the club who hold these privileges. This change does not allow for adding additional members to these classifications.

ARTICLE VI. OFFICERS

Section 4: DUTIES, A. President, 7.

Proposed Change: Delete the word "one" in the third line and insert the word "two".

If adopted would read:

- 7. At the expiration of her term she shall automatically become a director of the Mesquite Club for a two year term.

Rationale: It is essential that the expertise and experience of the immediate past president be available to the Executive Board for a two year period in order to guide the members of the Board who might be unfamiliar with the procedures, customs and historical purposes for actions that are being debated.

Note: If the above proposed change to ARTICLE VI. OFFICERS, Section 4: DUTIES, A. President.7. is passed the following section will also be changed to conform with the above change.

ARTICLE VIII. DIRECTORS

Section 1: DEFINITION

Proposed change: Delete the second sentence "At least one director...." and insert a new sentence:

"At least two directors shall be immediate Past Presidents; the other two shall be elected." If adopted would read:

The board of directors shall consist of four directors unless changed by amendment to these bylaws.

At least two directors shall be immediate Past Presidents; the other two shall be elected.

ARTICLE VI. OFFICERS

Section 4: DUTIES, F. Treasurer, 6.

Proposed change: Delete.

Rationale: It is no longer procedure for the Treasurer to receive rental checks. All funds go to the Financial Secretary to be deposited.

ARTICLE VI. OFFICERS

Section 4: DUTIES, G. Financial Secretary, 2.

Proposed change: In the first sentence delete the words "except rental checks,"

If adopted would read:

- 2. She shall receive all monies due to the Mesquite Club. She shall promptly transfer them to the Treasurer.

Rationale: Current procedure is for all funds to go to the Financial Secretary to be deposited.

ARTICLE XVI DISSOLUTION

Proposed Change: Delete. Insert new ARTICLE XVI DISSOLUTION

If adopted would read:

- A. In the event a vote is taken by the membership to divide or dissolve the club and/or the club's assets, both property and/or financial; it will require a three-fourths vote of those holding membership in

good standing to pass a division or dissolution motion. Changes to the provisions of ARTICLE XVI DISSOLUTION will require a three-fourths vote of those holding membership in good standing.

B. On the winding up and dissolution of this corporation, after paying or adequately providing for the debts, obligations, and liabilities of the corporation, the remaining assets of this corporation shall be distributed to G.F.W.C. Nevada, Inc. as the primary beneficiary or to the contingent beneficiary: The General Federation of Women's Clubs., if G.F.W.C. Nevada no longer exists. If such distribution is not possible, then distribution shall be to another charitable organization within Clark County, Nevada which has established its tax-exempt status under Internal Revenue Code section 501c(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. No assets may be distributed to individual members.

Rationale: If a group of members should propose changes to the club that result in the club dividing or dissolving, it should require a preponderance of the membership to agree to such changes. If the club assets are required to be transferred to G .F.W.C. Nevada, then there can be no dispute between factions of the membership regarding the future ownership of the assets. Assets could then be returned to those members proposing to continue the club in its historic and traditional form. This change in dissolution planning is being recommended by GFWC to protect the assets of clubs.

Gregory Fehr,

Gregory was recruited to Las Vegas in 1989 to work as an engineer for 3 years or so. His specialties are Metallurgical, Mechanical,

Corrosion, and Industrial

Engineering. In August, 1990, he married Kathleen Ingenthron, a long time Mesquite member. He decided to stay. In 2004, Gregory hung out his shingle and began a private practice under the banner of ATMG of Nevada.

While he has from time to time been involved with new construction e.g. buildings and pipes and water tanks for the SNWA and LVVWD, his main emphasis deals with *existing* structures and facilities. Based on his experience and his 16-year record of teaching approximately 104 sessions of the national seminar on *Structural Condition Assessment of Existing Structures* for the American Society of Civil Engineers, he specializes in evaluating the soundness of structures such as roller coasters, other amusement rides, monorails, trams, bridges, cooling towers, and water tanks. One of his largest clients is Cirque du Soleil where he provides periodic evaluation of the stage and acrobatic equipment for several of the shows to insure safety. In addition to designing cathodic protection systems using sacrificial anodes or impressed current to mitigate internal and external corrosion on metals, Greg and his staff provide a testing service to verify continued corrosion protection of pipes, water tanks, and underground fuel tanks as required by the Clark County Health District. The Disney Land "CARS" Ride systems were fabricated here in Las Vegas. Gregory's team provided visual weld inspection and nondestructive testing of metal components and welds including radiography and ultrasonic testing – similar to medical evaluations. A natural extension of these capabilities is *Failure Analysis*. Most of Gregory's failure analysis projects concern metal structures and parts, but failures of plastics and paint systems have found their way to ATMG.

Besides working with many of the major properties in town, Gregory's work also has extended to Sendai, Japan, Okinawa, Mexico City, Panama, Toronto, and the Republic of California. As a graduate of Oklahoma University, he has suffered many years of watching OU almost win the NCAA football championship. His wife, Kathy, acknowledges that Greg is semi-retired, but notes that the "semi" does not seem to be very big.

GFWC **RAFFLE!**

In 1983 when GFWC was preparing to celebrated its' 100th Birthday, the Goebel

Company of Germany was commissioned to create a series of four figurines depicting the women of the past 100 years.



The first figurine depicting 1890 – 1914 was offered for sale during the administration of Juanita Martin Bryant, 1982 – 1984. At the end of her term the mold was broken. The second figurine represents circa 1915 – 1939 and was offered during the administration of Jeri J. Winger, 1984 – 1986. Again the mold was broken. The third figurine represents circa 1940 – 1964 and was offered during the administration of Phyllis Vreeland Roberts, 1986 – 1988. Again the mold was broken. The fourth and final figurine depicting 1965 – 1990 was offered during the administration of Alice Clark Donahue, 1988 – 1990. The final mold was broken so that no more could be produced.

Today two sets reside in National Headquarters, one in the office of the president and the other in the 1728 third floor hallway cabinet. Through the generosity of one of our members we are offering a full set of the beautiful figurines as a raffle prize. The raffle will be closed at our April 16, 2016 GFWC Nevada State Convention. Tickets are \$10 each. It is not necessary to be present to win. Included with the figurines are two pages of the 125th Anniversary Postage Stamps issued by GFWC and the commemorative pin made available at the 125th Convention in Memphis, Tennessee. This is a value of approximately \$745.
