**CIRCUIT COURT CIVIL CASES**

Attorney has the option of filing case with Cost/Surety bonds only on Category One and Worker's Comp Cases. The following taxes would be only cost due at filing if filed with Surety/Cost Bonds:

Workers Comp/Category 1 filed with Cost Bond without service.....\$97.50  
Workers Comp/Category 1 filed w/ Cost Bond w/ one co service ....\$139.50  
Workers Comp without bond.....with one county service.....\$291.50  
Workers Comp without bond.....without service.....\$249.50

On cases were bond filed for Category one cases & Workers comp  
Filing fee is \$97.50 if no service; add \$42.00 for each service through county, \$20 for each service through Secretary of State, \$15 for each service through Commissioner of Insurance

Category One Cases (bond may be used)...with one service .....\$366.50
Without service .....324.50

Contracts, torts, personal injury, property damage, malpractice, wrongful death, employment
discrimination, civil rights suits, tax disputes, special remedies, cases and actions not otherwise designated.

Category Two Cases.....w/ one service .....\$291.50
W/out service ..... 249.50

Workers Comp cases(bond may be used), appeals to circuit from general sessions, city courts, juvenile
appeals, administrative hearings, writs of cert from lower courts or administrative hearings, transfers from
foreign counties, writs of mandamus, condemnation/inverse condemnation, & quo warranto actions.

Category Three Cases.....w/one service .....\$241.50
W/out service ..... 199.50

Adoptions, legitimations, paternity cases, termination of parental rights, & other domestic relations matters
not otherwise designated, restoration of citizenship, name changes, minor settlements, enforcement of
foreign judgments, and orders of protection. Fee not paid in advance on order of protections.
